**AGREED MOTION FOR SCHEDULING OF SUBSEQUENT
TESTIMONY AND BRIEFING PERIODS**

Via the parties' previous *Stipulation to Extension of Testimony Period* filed December 9, 2014, Petitioner's testimony period was extended (for a limited purpose) to January 31, 2015. However, that stipulation did not address the scheduling of subsequent testimony periods and related activities.

Under the Board's standard timetable, a defendant's pretrial disclosures are due 15 days after the plaintiff's testimony period ends, and the defendant's testimony period and the plaintiff's rebuttal testimony period are set at specific intervals thereafter. The 15 day period prior to the deadline for the defendant's pretrial disclosures serves the purpose, *inter alia*, of allowing the defendant to review the entirety of the plaintiff's testimony before deciding upon and identifying its own testimony period witnesses, etc.


Accordingly, Registrant requests that the following schedule be applied to this case:

Defendant's Brief Deadline	8/5/15
Plaintiff's Reply Brief Deadline	8/20/15
Request for Oral Argument Deadline	8/30/15


