Alpha Media Group, Inc. (hereinafter "AMG" or "Petitioner"), a corporation organized and existing under the laws of the State of Delaware, having a principal place of business at 415 Madison Avenue, New York, New York 10017, by and through its undersigned attorneys, states that it believes that it is damaged by the registration of the mark shown in Registration No. 1359595, issued on September 10, 1985 for the mark MAXIM (hereinafter, the "Registration"), owned by Maxim's Limited, a United Kingdom company with an address of 3, Rue Royale Paris France 75008, and hereby petitions for cancellation of same pursuant to 15 U.S.C. § 1064. The grounds for cancellation are as follows:

1. On September 10, 1985, Respondent obtained registration on the Principal Register of the trademark MAXIM'S DE PARIS on September 10, 1985 in International Class 33 in connection with the following goods: "wines; liqueurs namely bitter, anise,

aperitif, arack, digestive made from herbs and spirit liqueurs; geneva, gin, rum, schnapps, vodka, whiskey, prepared alcoholic cocktails, and hard cider.”

2. On or about February 28, 1991, Respondent filed its Combined Declaration of Use and Incontestability Under Sections 8 and 15 (the “1991 Declaration of Use and Incontestability”), stating that “the [MAXIM’S DE PARIS trademark that is the subject of the Registration] has been in continuous use in interstate commerce ... on all goods identified as follows: WINES; LIQUEURS NAMELY APERTIFS, DIGESTIVE MADE FROM HERBS AND SPIRIT LIQUEURS; SCHNAPPS.” A true and accurate copy of the 1991 Declaration of Use and Incontestability is annexed hereto as Exhibit A.

3. Upon information and belief, Respondent did not file a Declaration of Use within six (6) years following the Registration (or within the six months grace thereafter) in connection with any goods or services other than those identified in Paragraph 2 hereof and, in particular, did not file a Declaration of Use with respect to the following goods and services identified in the original Registration: liqueurs namely bitter, anise, arrack; geneva, rum, vodka, whiskey, prepared alcoholic cocktails and hard cider.

4. As a result of the failure to file a timely Declaration of Use with respect to liqueurs, namely bitter, anise, arrack; geneva, rum, vodka, whiskey, prepared alcoholic cocktails and hard cider, Respondent abandoned the Registration with respect to such goods.

5. On or about December 6, 2005, Respondent filed a Combined Declaration of Use in Commerce and Application for Renewal of a Mark Under Sections 8 and 9 (the “Second Renewal”), requesting that the following goods be deleted from the Registration:

“wines, bitter, anise, aperitif, arrack, digestive made from herbs and, geneva, rum, schnapps, prepared alcoholic cocktails, hard cider.” A true and accurate copy of the Second Renewal is annexed hereto as Exhibit B.

6. As a result of the further deletions set forth in the Second Renewal, the sole remaining good as to which the Registration purportedly applies is “liqueurs namely spirit liqueurs.”

7. Petitioner is the publisher of Maxim, the most popular and successful men’s lifestyle magazine in the United States and throughout the world, and of Maxim’s website located at www.maxim.com. Petitioner is the owner of the following US registrations for MAXIM:

- US Registration Number 2,072,696 for MAXIM in Class 16 in connection with magazines concerning men’s lifestyle and popular culture.
- US Registration Number 3,228,647 for MAXIM in Class 28 in connection with playing cards.
- US Registration Number 3,127,276 for MAXIM in Class 21 in connection with Beer mugs, bottle openers, bowls, boxes for dispensing paper towels, brooms, butter dishes, candle holders not of precious metals, candlesticks not of precious metals, carving boards, cat litter boxes, champagne buckets, cleaning combs, cleaning pads, clothes brushes, coasters not of paper and not being table linen, cocktail picks, cocktail shakers, coffee cups, colanders for household use, household containers for foods, cooking pots, cork screws, cups, cutting boards, decanters, dish drying racks, dish stands, drinking flasks, drinking glasses, dust pans, Dutch Ovens, electric or non-electric toothbrushes, feather dusters, fireplace brushes, flower pots, frying pans, furniture dusters, glass articles, namely, decorative stained glass, glass bowls, gravy boats, hair brushes, hair combs, hip flasks, household utensils, namely, graters, ice buckets, ice cube molds for refrigerators, insulated flasks, ironing boards, kitchen ladles, lawn sprinklers, lemon squeezers, mixing spoons, mops, mouse traps, non-electric coffee pots not of precious metals, non-electric tea kettles, pepper mills, pet feeding dishes, pitchers, plastic bath racks,

plastic coasters, plates, polishing cloths, portable beverage coolers, portable ice chests for food and beverages, rubber household gloves, salt shakers, saucepans, scrubbing brushes, serving ladles, serving spoons, shaped ironing board covers, shoe brushes, shower caddies, slotted spoons, soap dishes, soap dispensers, spice racks, sprayers attached to garden hoses, swizzle sticks, tea sets, tea kettles, thermal insulated containers for food or beverages, toilet brushes, toilet paper holders, toothpick holders, towel racks, vacuum flasks, wastepaper baskets, watering cans, window dusters, wine bottle cradles, wine cooling buckets, and wine racks

- US Registration Number 3,261,379 for MAXIM in Class 34 in connection with tobacco, namely smoking tobacco, pipe tobacco, cigarette tobacco, chewing tobacco, snuff, cigars, cigarettes, cigarillos; smoker's articles, namely pipes, pipe filters, cleaners, racks, stands, trays, stems and tools, humidors, cigarette paper, tobacco pouches, cigar, cigarette, pipe and tobacco boxes and pouches, ashtrays not of precious metal for smokers, tobacco jars, tobacco knives, lighters for smokers, smokers' cases and cutters, cigar and cigarette holders, scissors for smokers; matches
- US Registration Number 4,168,240 for MAXIM in Class 28 in connection with gaming equipment, namely poker chips, card shufflers, dealer marker and dice shakers
- US Registration Number 3,610,369 for MAXIM in Class 43 in connection with bar services; restaurants; restaurant services
- US Registration Number 2,449,119 for MAXIM in Class 42 in connection with providing on-line information on a variety of topics concerning men's lifestyle and popular culture

Petitioner further owns the following applications for MAXIM in connection with which Notices of Allowance have been issued:

- US Serial Number 85217714 for MAXIM in Class 25 in connection with bathing suits; beach coverups; beachwear; bikinis; blazers; blouses; board shorts; boxer briefs; boxer shorts; bralettes; bras; briefs; bustiers; camisoles; coats of denim; collared shirts; corsets; denim jackets; denims; g-strings; headgear, namely, caps and hats; hooded sweatshirts; jackets; jeans; jogging pants; knit shirts; ladies' underwear; leggings; lingerie;

loungewear; men's underwear; negligees; night gowns; night shirts; pajama bottoms; pajamas; panties; pants; polo shirts; robes; shapewear, namely, girdles and bras; shorts; skirts and dresses; socks; sport shirts; suits; sweatpants; sweatshirts; tank tops; tap pants; teddies; tee shirts; thongs; ties; track pants; undershirts; underwear; underwear, namely, boy shorts; wearable garments and clothing, namely, shirts; women's underwear.

- US Serial Number 78493595 for MAXIM in Class 14 in connection with jewelry, namely, brooches, bracelets, pendants, jewelry chains, cufflinks, ear rings, tie tacks, pins, necklaces and rings, all of precious metal, and excluding watches of precious and non-precious metals
- US Serial Number 77691270 for MAXIM in Classes 41 and 43 in connection with night club services; on-line journals, namely, blogs featuring gaming, humor, beauty contests, movies, books, sports, videos, popular culture and men's lifestyles; entertainment services, namely, providing a web site featuring video reviews, related film clips, and photographs featuring men's lifestyles and popular culture; entertainment services, namely, providing a website featuring online magazines, news and articles on the concerns and interests of men, namely, history, physical fitness, sports, books, music, popular culture, movies, video games, literature, fine arts, computer game reviews and humor-oriented writings (Class 41), and with cocktail lounge services (Class 43)

8. On June 7, 2013, Petitioner filed a trademark application (assigned Serial No. 85953400), on an intent to use basis, for the trademark MAXIM in International Class 33 in connection with alcoholic beverages except beers; bourbon; brandy; gin; liqueurs; scotch; tequila; vodka; whisky; wine. Petitioner intends to enter into a joint venture agreement pursuant to which it would market vodka under the MAXIM trademark in the United States.

9. Upon information and belief, it is likely that the United States Patent and Trademark Office ("USPTO") will refuse registration of the trademark MAXIM for vodka on the basis of a likelihood of confusion with the Registration.

COUNT I

10. Petitioner repeats and realleges each and every allegation in the foregoing paragraphs as if fully set forth herein.

11. In or about 1991, Respondent abandoned the Registration insofar as it relates to liqueurs, namely bitter, anise, arrack; geneva, rum, vodka, whiskey, prepared alcoholic cocktails and hard cider.

12. In or about 2005, Respondent further abandoned its Registration insofar as it relates to wines, aperitif, digestive made from herbs, and schnapps (and, to the extent not previously abandoned, with respect to bitter, anise, arrack, rum, prepared alcoholic cocktails, hard cider).

13. As a result of the foregoing, the sole goods as to which trademark maintenance documents have been filed are “liqueurs namely spirit liqueurs.”

14. The specimen submitted with the Second Renewal is improper and ineffective, as it is a bottle of whiskey, which is not a liqueur; therefore, no appropriate specimen was submitted in support of the Second Renewal.

15. Because trademark maintenance documents have not been properly filed with respect to the Registration, the Registration should be cancelled.

COUNT II

16. Petitioner repeats and realleges each and every allegation in the foregoing paragraphs as if fully set forth herein.

17. Upon information and belief, Respondent has never used, or is no longer using, the mark MAXIM’S DE PARIS in connection with goods covered by the Registration.

18. Upon information and belief, Respondent no longer has any intent to resume use of the mark MAXIM'S DE PARIS in connection with goods covered by the Registration.

19. Continued registration of the mark shown in the Registration will damage the Petitioner pursuant to the allegations stated above, and will create a cloud on the lawful right of Petitioner to adopt and use of MAXIM in connection with vodka, and will prevent Petitioner from obtaining federal registration of the mark MAXIM in connection with vodka in the name of Petitioner.

20. Petitioner, for the reasons set forth above, believes that it is or will be damaged by the continued registration of Respondent's Mark.

COUNT III

21. Petitioner repeats and realleges each and every allegation in the foregoing paragraphs as if fully set forth herein.

22. Upon information and belief, despite making a declaration to the USPTO, in connection with his application to the contrary, Respondent did not have a *bona fide* intent to use the mark MAXIM'S DE PARIS in United States commerce on or in connection with all of the goods identified in its U.S. Application Serial No. 73508464, as amended in response to an Office Action, namely, "Wines; liqueurs namely bitter, anise, aperitif, arrack, digestive made from herbs and sprit liqueurs; geneva, gin, rum, schnapps, vodka, whiskey, prepared alcoholic cocktails and hard cider" when it filed such application, which resulted in Registration No. 1359595; the Registration at issue herein.

23. Upon information and belief, despite making a declaration to the USPTO, in connection with the Second Renewal to the Contrary, Respondent did not have a *bona*


fide intent to use the mark MAXIM'S DE PARIS in United States commerce on or in connection with all of the goods identified in such declaration, that is, liqueurs namely spirit liqueurs.

24. Upon information and belief, to the extent that the Second Renewal may be interpreted as referring to any goods in addition to liqueurs namely spirit liqueurs, then despite any such declaration to the USPTO, Respondent did not have a *bona fide* intent to use the mark MAXIM'S DE PARIS in United States commerce on or in connection with such goods.

25. Petitioner, for the reasons set forth above, believes that it is or will be damaged by the continued registration of Respondent's Mark.

WHEREFORE, Petitioner asks that its Petition for Cancellation be sustained and that the Registration of the mark MAXIM'S DE PARIS in Class 33 set forth therein be cancelled.
