1. Since at least as early as 2005, Meritas, and its subsidiaries, affiliates, and/or licensees have been engaged in the offering and rendering of educational services and related goods and services, in connection with the MERITAS trademark.
2. Meritas is the owner of the MERITAS trademark and U.S. Trademark Registration No. 3,160,682 for the MERITAS trademark. A copy of the registration certificate, title history, and a TSDR status printout from the USPTO database are attached hereto as **Exhibit A**. The registration certificate was obtained in 2006 and claims a first use date of at least as early as March 8, 2005. The registration has achieved incontestable status under Trademark Act Section 15, 15 U.S.C. §1065.
3. Meritas' MERITAS registration covers "Providing educational services, namely, courses of instruction for kindergarten through 12th grade and operation of private schools for kindergarten through 12th grade; summer camps for kindergarten through 12th grade" in International Class 41. The MERITAS mark is used in the U.S. and throughout the world in connection with Meritas' family of exclusive private schools, and goods and services offered therefrom.
4. In addition to its U.S. registration for the MERITAS mark, Meritas owns trademark applications and registrations for MERITAS in Mexico, Europe, Australia, and Russia, and in individual jurisdictions throughout Latin America, Africa, and Asia. Details regarding Meritas' foreign applications and registrations for MERITAS and variant marks are shown in the chart attached hereto as **Exhibit B**.

5. Meritas and its predecessors-in-interest, subsidiaries, affiliates, and/or licensees have used the MERITAS mark in U.S. commerce, continuously and exclusively, for more than seven years.
6. Meritas advertises its MERITAS schools, educational services, and related goods and services worldwide on the Internet, through its website located at the Uniform Resource Locator (“URL”) www.meritas.net.
7. Meritas’ MERITAS mark is widely recognized and is “famous” within the meaning of the Trademark Act Section 43, 15 U.S.C. § 1125(c)(1), and was famous on and prior to any priority date on which the Registrant could rely.
8. On April 27, 2012, Registrant filed its application to register AMERITAS COLLEGE for “Educational Services, namely, providing instruction and training at the undergraduate and graduate levels” in International Class 41.
9. Registrant’s application to register AMERITAS COLLEGE was filed based on an intent-to-use the mark under Trademark Act Section 1(b). 15 U.S.C. § 1051(b). The application disclaimed the generic term “COLLEGE.” Registration issued for the mark on June 11, 2013.
10. Registrant’s alleged AMERITAS COLLEGE mark, as shown in Registration No. 4,351,285, incorporates Meritas’ MERITAS mark in its entirety, and the dominant portion of the mark, “AMERITAS” is visually and audibly similar to Meritas’ MERITAS mark.


11. The goods and services covered by Registrant's Registration No. 4,351,285, and the services offered or proposed to be offered by Registrant under Registrant's AMERITAS COLLEGE mark, are similar to, or related to, those covered by the MERITAS mark and MERITAS trademark registration.
12. Upon information and belief, the Registrant's services and the services offered in connection with Meritas' MERITAS mark or from Meritas' MERITAS schools overlap and would be available to and marketed to the same or similar consumers, through common channels of trade.
13. Upon information and belief, use of the MERITAS mark in U.S. commerce commenced more than six years prior to Registrant's filing of an application to register AMERITAS COLLEGE and at least seven years prior to any demonstration of use of AMERITAS COLLEGE in U.S. commerce.
14. Registrant's AMERITAS COLLEGE registration incorporates a mark previously used and registered in the United States, namely Meritas' MERITAS mark. Registrant's AMERITAS COLLEGE registration claims and is used or intended for use in connection with services identical to or related to those services offered by Meritas under its MERITAS mark, and is therefore likely to confuse, deceive or mislead purchasers or prospective purchasers with regard to source, sponsorship or affiliation by or between Meritas and Registrant, in violation of Section 2(d) of the Trademark Act, 15 U.S.C. §1052(d).

15. Further, if sustained, Registrant's AMERITAS COLLEGE registration could dilute the distinctive quality of the famous MERITAS mark, in accordance with Trademark Act Section 43(c), 15 U.S.C. §1125(c).
16. As a result, continued registration by the Registrant will cause substantial damage and injury to Meritas and Registrant is not entitled to continued registration for the claimed mark.

WHEREFORE, Meritas respectfully requests that this cancellation action be sustained and that Registration No. 4,351,285 for AMERITAS COLLEGE be cancelled.
