PETITION FOR CANCELLATION

Petitioners, Maybach Music Group, LLC, a Florida limited liability company (hereinafter “MMG LLC”), and William L. Roberts II, a/k/a Rick Ross (hereinafter “Ross”), a United States citizen, both of which have a business address of 200 Park Avenue South, Suite 1408, New York, New York 10003, believe they are being damaged by the registration of the mark Maybach Entertainment, covering party planning services, Registration No. 3823080; and Film production services; Music production services; Music video production services; Production of theatrical plays, Registration No. 4077668, issued to Maybach Entertainment LLC (hereinafter, “ME” or “Registrant”). Petitioners thus request cancellation of the same.

As grounds for this Petition, Petitioners allege as follows:

1. Ross is an American hip hop music performing and recording artist of significant renown and celebrity in the United States and around the world. Ross’ debut album was released in 2006, and he has enjoyed success in the music recording and performing industry since that time.

2. On or about July 13, 2007, Ross, acting in his capacity as managing member, formed Maybach Music Group, LLC, and took the steps required by the State of Florida to

establish Maybach Music Group, LLC as a Florida limited liability company. Attached as Exhibit A is a true copy of the print out of the Florida Secretary of State Corporations Division database showing Maybach Music Group, LLC effective as of July 13, 2007.

3. Since the time of its formation in July 2007, MMG LLC and Ross (collectively “MMG”) have promoted MAYBACH MUSIC GROUP as a music recording label and used the name and trademark MAYBACH MUSIC GROUP as the name of a recording label under which musical artists record musical works.

4. Since July 2007, MMG has actively engaged in scouting and recruitment of musical artists to join the MAYBACH MUSIC GROUP label, and have used the MAYBACH MUSIC GROUP mark since July 2007 in such activities in the music industry. As such, the MAYBACH MUSIC GROUP name has become known in the music entertainment industry as identifying the recording services and record label associated with Petitioners and only Petitioners.

5. In 2008, MMG signed the hip hop musical artists Masspike Miles, Torch, and Gunplay to the MAYBACH MUSIC GROUP recording label. In November 2008, Masspike Miles’ recording “‘The Pursuit’ of Happiness” was released on the MAYBACH MUSIC GROUP label. Also in November 2008, Torch’s recording “SkiMask Music” and Gunplay’s recording “Sniffahill: The First Gram” were released on the MAYBACH MUSIC GROUP label. Attached as Exhibits B - D are copies of covers of the three recordings bearing the MAYBACH MUSIC GROUP label name.

6. In early 2008, MMG also embarked on film and video production, with the debut film release of the documentary film “M.I. Yayo” in March 2008. MMG thus is a multi-media production enterprise dating from at least as early as March 2008.

7. Effective January 5, 2009 the MAYBACH MUSIC GROUP recording label operated under the Island Def Jam Music Group, which distributed the MAYBACH MUSIC GROUP label recordings throughout the United States and internationally.

8. 2009 brought the musical hip hop group Triple C’s to the MAYBACH MUSIC GROUP label. Triple C’s recording Custom Cars & Cycles was released on October 27, 2009.

9. In 2009, the MAYBACH MUSIC GROUP’ label expanded to include reggae music with the addition of reggae artist Magazeen to MMG’s stable of recording artists. The label later expanded to include a Latino sub-brand, Maybach Music Latino.

10. Rick Ross, already signed on to the MAYBACH MUSIC GROUP label in his individual capacity as a musical recording artist, publicly announced the development of his upcoming recording “Deeper than Rap” in May 2008. The album, released on April 21, 2009, debuted at number one on Billboard magazine’s weekly ranking of the 200 highest-selling music albums in the United States, the Billboard 200. It sold 158,000 copies in its first week.

11. From 2009 to 2011, the MAYBACH MUSIC GROUP label signed such young urban musical artists as Wale, Meek Mill, Stalley, Omarion, DJ Scream, and Rockie Fresh.

12. The MAYBACH MUSIC GROUP record label continues to expand to the present date.

13. In February 2011, distribution of the MAYBACH MUSIC GROUP label recordings transferred to Warner Bros. Records, and then in December 2012, to Atlantic Records, where the MAYBACH MUSIC GROUP label remains.

14. MMG adopted and has used the MAYBACH MUSIC GROUP name and mark continuously in commerce the offering of musical recording services since at least as early as July 2007. Such use has been extensive throughout the U.S. and has become uniquely associated with MMG, exclusively, throughout the U.S. and internationally. As a result of the quality of services offered under the mark, the mark has come to represent substantial goodwill inuring to the benefit of MMG.

15. It is customary practice in the music recording industry for record labels to host parties just prior to the release of a new record, to promote the artist and the record to the public. These events are planned on a very large scale, usually renting out clubs, replete with star-studded celebrity guest lists and red-carpet photo opportunities. MMG regularly hosts such events, dubbed “release parties,” for its artists, thus the MAYBACH MUSIC GROUP name and mark is also associated with hosting such parties and special events in the music industry.

16. According to the records of the Oregon Secretary of State, Corporation Division, Registrant, ME, is an inactive Oregon limited liability company, having been administratively dissolved for failure to file an annual report in 2011. According to the same records, the registered agent for service of process of Registrant, ME is Ali Abuhamdeh, of 2422 NW Wessex Ter, Hillsboro, Oregon 97124. A true and correct copy of the print out of the Oregon Secretary of State, Corporation Division status page for ME is attached as Exhibit E.

17. According to the records of the Oregon Secretary of State, Corporation Division, the legal entity Maybach Entertainment LLC was formed on August 25, 2009, when the articles of organization were filed with the Oregon Secretary of State. A true and correct copy of the

Articles of Organization as obtained from the database of the Oregon Secretary of State, Corporation Division is attached as Exhibit F. As shown on Exhibit E, the “start date” for the entity given on the Oregon Secretary of State’s website is *August 25, 2009*.

18. According to the records of the United States Patent and Trademark Office, the application from which Reg. No. 3823080 issued, i.e., Application Serial No. 77/800182, was filed on *August 7, 2009*. Application Serial No. 77/800182 was filed on August 7, 2009 in the name of owner “Maybach, Entertainment, LLC” (sic), an Oregon limited liability company. On August 7, 2009, no Oregon limited liability company named Maybach Entertainment LLC existed according to the records of the Oregon Secretary of State Corporation Division.

19. Application Serial No. 77/800182, filed on August 7, 2009, was based on Section 1(b), with no use of the mark claimed in the application as filed.

20. Upon information and belief, ME made no use of the Maybach Entertainment mark prior to the August 7, 2009 filing of Application Serial No. 77/800182.

21. Upon information and belief neither ME nor any predecessor in interest or affiliated persons or entities made any use of the Maybach Entertainment mark prior to the August 7, 2009 filing of Application Serial No. 77/800182.

22. Upon information and belief, the August 7, 2009 filing date of Application Serial No. 77/800182 is the earliest date upon which ME can rely in establishing priority in the Maybach Entertainment mark.

23. Upon information and belief, the August 7, 2009 filing date of Application Serial No. 77/800182 is the earliest date upon which ME or any predecessor in interest or affiliated persons or entities can rely in establishing priority in the Maybach Entertainment mark.

24. Application Serial No. 85/018030, from which Reg. No. 4077668 issued, filed on April 20, 2010, was based on Section 1(b), with no use of the mark for “Film production services; Music production services; Music video production services; Production of theatrical plays” claimed in the application as filed.

25. Upon information and belief, ME made no use of the Maybach Entertainment mark for “Film production services; Music production services; Music video production services; Production of theatrical plays” prior to April 20, 2010.

26. Upon information and belief neither ME nor any predecessor in interest or affiliated persons or entities made any use of the Maybach Entertainment mark for “Film

production services; Music production services; Music video production services; Production of theatrical plays” prior to April 20, 2010.

27. Upon information and belief, the April 20, 2010 filing date of Application Serial No. 85/018030 is the earliest date upon which ME can rely in establishing priority in the Maybach Entertainment mark for “Film production services; Music production services; Music video production services; Production of theatrical plays”.

28. Upon information and belief, the April 20, 2010 filing date of Application Serial No. 85/018030 is the earliest date upon which ME or any predecessor in interest or affiliated persons or entities can rely in establishing priority in the Maybach Entertainment mark for “Film production services; Music production services; Music video production services; Production of theatrical plays”.

29. Petitioners first adopted the name MAYBACH MUSIC GROUP at least as early as July 13, 2007, when the limited liability company was organized in Florida.

30. Petitioners first used the name MAYBACH MUSIC GROUP at least as early as July 13, 2007 and continuing to the present time in promoting the music recording services offered under the same name.

31. Petitioners MMG first used the MAYBACH MUSIC GROUP mark in commerce at least as early as July 13, 2007, long prior to the filing dates of the applications from which Registration Nos. 3823080 and 4077668 issued as well as the dates of first use claimed in the Statements of Use filed in the applications from which Registration Nos. 3823080 and 4077668 issued. Thus Petitioners have priority of use of the MAYBACH mark over Registrant ME, either as to that created by the federal trademark applications or through use.

32. In July 2013, a representative of the owner of the trademark Maybach Entertainment threatened MMG with litigation against MMG and its distribution partners, past and present, arising out of MMG’s use of the Maybach trademark. A true and accurate copy of the Registrant’s claim sent by mail and ultimately received by Petitioners is attached as Exhibit F and incorporated herein by reference.

33. The claim by the trademark registration owner in the aforementioned objection email to Petitioners is an admission that infringement is occurring and that likelihood of confusion exists.

34. The services in Registration Nos. 3823080 and 4077668 are identical to or closely related to Petitioners’ goods and services.

35. The dominant components of the respective marks are identical.

36. Petitioners' prior common law use of the mark creates priority of right, and therefore the right to use and registration belongs to Petitioners, not to Registrant.

37. Maintaining Registration Nos. 3823080 and 4077668 on the Federal register is inconsistent with Petitioners' rights under the common law, and is damaging to Petitioners.

WHEREFORE, Petitioners pray that this Petition be granted and that Registration Nos. 3823080 and 4077668 be cancelled.
