**PETITION FOR CANCELLATION**

Petitioner, BBY Solutions, Inc., a Minnesota corporation having a principal place of business at 7601 Penn Avenue South, Richfield, MN, 55423, ("Petitioner"), believes that it is being damaged and will continue to be damaged by registration of the mark shown in Registration No. 3,480,164 for the mark FACTORY 2-U & Tag Design and hereby petitions to cancel the same under the provisions of 15 U.S.C. § 1064.

As grounds for the cancellation, Petitioner asserts that:

1. Petitioner's parent company Best Buy Co., Inc. ("Best Buy Co.") is one of the nation's largest retailers, offering a wide range of products through its retail stores and BestBuy.com website. Petitioner is the owner of the trademarks used by Best Buy Co.'s operating companies Best Buy Stores, L.P. and BestBuy.com, L.L.C., which operate the Best Buy retail stores and website, respectively, and are licensed by Petitioner. Petitioner, Best Buy Stores, L.P. and BestBuy.com, L.L.C. and their predecessors-in-interest are referred to collectively as "Best Buy."

2. Best Buy is the owner of the BEST BUY and Tag Design mark and the Tag Design mark (collectively, the “Best Buy Tag Design Marks”) for, inter alia, retail store services for a variety of consumer products. Best Buy adopted and began using the Best Buy Tag Design Marks at least as early as 1989. Best Buy has continuously used the Best Buy Tag Design Marks and related tag design marks in connection with retail store services and products since their adoption.

3. In addition to the BEST BUY logo, the Tag Design Mark has been used in countless other formats in promoting Best Buy’s retail services, such as tag-shaped pricing displays, tag-shaped gift cards, tag-shaped signage, and tag-shaped suggestion boxes.

4. Best Buy’s BEST BUY retail stores and/or its BestBuy.com online retail website offer for sale a wide range of consumer products under the Best Buy Tag Design Marks, including, without limitation, consumer electronics, appliances, home office products and supplies, entertainment products, clothing items, housewares, luggage, and toys. In addition to the retail sale of new consumer products, Best Buy also uses the Best Buy Tag Design Mark in connection with the retail sale of used and refurbished items at its Best Buy stores, BestBuy.com website and at its eBay site (<http://stores.ebay.com/Best-Buy-Outlet-Store>). Since their adoption, Best Buy has continually expanded the nature and extent of products and services offered under the Best Buy Tag Design Marks.

5. Best Buy is the owner of the following U.S. Trademark Registrations for the Best Buy Tag Design Marks:

6. U.S. Service Mark Registration Nos. 2,196,852, 1,899,212, and 1,657,622, are valid, subsisting, enforceable, and incontestable pursuant to 15 U.S.C. § 1065. U.S. Service Mark Registration No. 3,615,955 is valid, subsisting and enforceable. Complete printouts from the TSDR database for these registrations are attached as Exhibit A.

7. Best Buy has continuously promoted its goods and services under the Best Buy Tag Design Marks nationwide through various media, including at Best Buy retail stores, in print advertising, on television and the Internet (including web-based advertising and on its own website, located at [www.BestBuy.com](http://www.BestBuy.com)), sponsorship of entertainment and sporting events, and on various promotional items. Moreover, the Best Buy Tag Design Marks are prominently displayed on Best Buy employee uniforms and in the exterior signage of over 1000 Best Buy retail stores nationwide.

8. Best Buy has expended considerable effort and expense in promoting the Best Buy Tag Design Marks and the services offered under the marks with the result that the purchasing

public has come to know, rely upon and recognize the services of Best Buy by the Best Buy Tag Design Marks. Best Buy has established valuable goodwill in its Best Buy Tag Design Marks.

9. As a result of these efforts, the Best Buy Tag Design Marks have become famous and closely associated with Best Buy and its services.

10. The Best Buy Tag Design Marks are inherently distinctive.

11. Respondent I & K Vending, Inc. (“Respondent”) is the current owner of record of U.S. Registration No. 3,480,164 (the “Registration”) for the mark FACTORY 2-U & Tag Design shown below (“Respondent’s Mark”) for “retail discount store services in the field of clothing, housewares, luggage and toys” in International Class 35 (“Respondent’s Services”).



12. Respondent’s registration and use of Respondent’s Mark has not been authorized by Best Buy nor is Respondent affiliated with Best Buy.

13. There is no issue as to priority. The application for Respondent’s Mark was filed on January 2, 2008 with a claimed first use date of May 2005 and the mark registered on August 5, 2008. In contrast, Best Buy has continuously used the BEST BUY and Tag Design and Tag Design marks in commerce since at least as early as 1989.

14. The Best Buy Tag Design Marks became famous prior to the application date and first use of Respondent’s Mark.

15. Respondent’s Services are similar to and compete with services offered by Best Buy under the Best Buy Tag Design Marks.

16. Respondent's Services are likely to be offered through similar channels of trade as are Best Buy's services under the Best Buy Tag Design Marks.

17. Respondent's Services are likely to be sold and marketed to the same or similar consumers as are Best Buy's services under the Best Buy Tag Design Marks.

18. Respondent's Mark so resembles the Best Buy Tag Design Marks as to be likely, when used on or in connection with Respondent's Services, to cause confusion, or to cause mistake. Customers and prospective customers are likely to mistakenly believe that Respondent's Services offered under Respondent's Mark are sponsored, endorsed, or approved by Best Buy, or are in some way affiliated, connected, or associated with Best Buy. The Registration therefore should be cancelled under 15 U.S.C. § 1052(d).

19. Respondent's Mark so resembles the Best Buy Tag Design Marks as to be likely, when used on or in connection with Respondent's Services, to dilute the distinctive quality of the Best Buy Tag Design Marks. The Registration therefore should be cancelled under 15 U.S.C. §§ 1125(c).

20. Registration of Respondent's Mark is a source of damage to Best Buy because purchasers are likely to attribute the source or sponsorship of Respondent's services to Best Buy.

21. Registration of Respondent's Mark is a further source of damage to Best Buy because it confers upon Respondent various statutory presumptions to which it is not entitled in view of long prior use of the Best Buy Tag Design Marks by Best Buy.




