PETITION TO CANCEL REGISTRATION NO. 3,609,068

R&R Family L.P. (hereinafter "Petitioner"), a limited partnership duly organized and existing under the laws of Texas, having an address at P.O. Box 210487, Bedford, Texas 76021, whose general partner is R&R Family Management, LLC, a Texas limited liability company, believes that it is damaged by Registration No. 3,609,068 and hereby petitions to cancel the same.

As grounds for this Petition, it is alleged:

1. Petitioner has filed an application to register the trademark AMERICAN IRONHORSE, Application Serial No. 85/640026 in connection with Motorcycles; motorcycle parts and accessories; gas tanks; fenders; handle bars; exhaust systems; frames; wheels; clothing.
2. The U.S. Patent and Trademark Office has issued a refusal of registration of Petitioner's application identified in Paragraph 1 hereof based upon the allegation of a likelihood of confusion with the mark shown in Registration No. 3,609,068 (hereinafter "the Registered Mark").

3. After investigation and upon information and belief, Registrant is not currently using, and has abandoned use of the Registered Mark in the United States in connection with the goods listed in the subject registration.
4. After investigation and upon information and belief, Registrant has no plans to resume use of the Registered Mark in the United States in connection with the goods listed in the subject registration.
5. Upon information and belief, the owner of the subject registration, AIH Acquisition Company LLC has ceased operations and the company's assets were liquidated.
6. If the Registrant is permitted to retain Registration No. 3,609,068 a cloud will be placed on Petitioner's Application, on the mark that is the subject of Petitioner's Application, and on Petitioner's right to use, register and expand the use of that mark. Continued registration of the Registered Mark would thus be a source of damage and injury to the Petitioner.

WHEREFORE, Petitioner respectfully requests that this Petition be granted and that Registration No. 3,609,068 be canceled.
