PETITION TO CANCEL

Petitioner, Bugatti International S.A. ("Petitioner"), a corporation of Luxembourg having an address at 412F Route d-Esch Luxembourg, Luxembourg 1030, believes that it will be damaged by Registration No. 2606320, registered August 13, 2002 for the mark BUGATTI, and hereby petitions to cancel the same. The grounds of the petition are as follows:

1. This petition is being brought under 15 U.S.C. § 1064(3) based upon fraudulent assertion of goods sold in commerce in the Section 8 and Section 15 Declarations filed for Registration No. 2606320 and the Section 8 and Section 9 Use Declaration and Application for Renewal for Registration No. 2606320.

2. Petitioner, Bugatti International is the worldwide owner of the famous BUGATTI trademark and the equally famous BUGATTI Logo for automobiles,



the famous Bugatti Veyron being the fastest production automobile in the world. Petitioner also engages in extensive licensing of its Bugatti trademarks for a variety of products including but not limited to jewelry, watches, model cars, and leather products, for which it owns registered trademarks throughout the world and in the United States in particular. Relevant U.S. registrations are annexed hereto as Exhibit A.

3. Registrant, Charles Bugatti, a citizen of the United Kingdom with an address at 4818 Sweetmeadow Circle, Sarasota, Florida 34238, is the owner of Registration No. 2606320 covering the mark BUGATTI for hair care products, namely, hair shampoo, hair conditioner, hair gel, hair spray and hair and face mist in International class 3.

4. The application that resulted in Registration No. 2606320 was filed April 30, 1999, based on use in commerce, alleging use since 1972; the registration issued August 13, 2002.

5. On or about June 25, 2002, Registrant granted an exclusive trademark license to Petitioner to use the BUGATTI mark covered by the instant Registration Nos. 2606320 and a second U.S. Registration No. 2728726, respectively for the goods covered by each registration in class 3, which license Petitioner has recently terminated on the grounds of breach by Registrant.

6. On or about May 13, 2008, Registrant's counsel of record filed a section 8 & 15 use declaration and specimens on behalf of Registrant, in Registration No. 2606320, in which he declared that:

... the mark is in use in commerce on or in connection with all of the goods or services listed in the existing registration for this specific class; and the mark has been continuously used in commerce for five (5) consecutive years after the date of registration, or the date of publication under Section 12(c), and is still in use in commerce on or in connection with **all** goods or services listed in the existing registration for this class.

Further declaring:

The owner, or its related company, is using the mark in commerce on or in connection with the goods and/or services identified above, as evidenced by the attached specimen(s) showing the mark as used in commerce. The owner, or its related company, has continuously used the mark in commerce on or in connection with the goods and/or services identified above, for five (5) consecutive years after the date of registration, or the date of publication under Section 12(c), and is still using the mark in commerce on or in connection with the identified goods and/or services.

A copy of the USPTO online TSDR record of Registrant's 8 & 15 use declaration is attached hereto as Exhibit B.

7. On information and belief, no products covered by the subject Registration No. 2606320 for hair care products, namely, hair shampoo, hair conditioner, hair gel, hair spray and hair and face mist, bearing the Bugatti mark, had been sold in the United States between the effective date of the license agreement in 2002 and the filing of the section 8 use declaration and section 15 incontestability declaration in 2008.

8. On information and belief, the specimens submitted in support of the section 8 and 15 use and incontestability declarations filed in Registration No. 2606320 were the same specimens filed with the initial application in 1999 and were not in use in 2008. A copy of the specimens submitted by Registrant in support of its section 8 declaration taken from the USPTO online TSDR records is attached hereto as Exhibit C.

9. On or about August 3, 2012, Registrant's attorney of record filed on its behalf a declaration of use under Section 8 and a Section 9 renewal application in Registration No. 2606320 stating:

For International Class 003, the mark is in use in commerce on or in connection with **all** goods or services listed in the existing registration for this specific class: hair care products, namely, hair shampoo, hair conditioner, hair gel, hair spray and hair and face mist; or, the owner is making the listed excusable nonuse claim.

The owners are submitting one (or more) specimen(s) showing the mark as used in commerce on or in connection with any item in this class, consisting of a(n) photographs of bottles bearing the trademark containing hair shampoo, hair

conditioner, hair and face mist, hair gel and hair spray.

Further declaring:

Section 8: Declaration of Use in Commerce

Unless the owner has specifically claimed excusable nonuse, the mark is in use in commerce on or in connection with the goods and/or services identified above, as evidenced by the attached specimen(s) showing the mark as used in commerce.

Section 9: Application for Renewal

The registrant requests that the registration be renewed for the goods and/or services identified above.

The undersigned being hereby warned that willful false statements and the like are punishable by fine or imprisonment, or both, under 18 U.S.C. Section 1001, and that such willful false statements and the like may jeopardize the validity of this document, declares that he/she is properly authorized to execute this document on behalf of the Owner; and all statements made of his/her own knowledge are true and that all statements made on information and belief are believed to be true.

A copy of the USPTO online TSDR record of registrant's section 8 & 9 renewal application is attached hereto as Exhibit D.

The same specimens were submitted in support of the section 8 and 9 renewal application as had been previously submitted for the initial application and the false and fraudulent section 8 and 15 use and incontestability declarations. The supporting specimens taken from the USPTO online TSDR records are attached hereto as Exhibit E.

10. On information and belief, no products covered by the subject Registration No. 2606320, namely hair care products, namely, hair shampoo, hair conditioner, hair gel, hair spray and hair and face mist, bearing the Bugatti mark, had been sold in the United States between the effective date of the license agreement in 2002 and the filing of the section 8 use declaration accompanying the renewal application filed in August of 2012.

11. On information and belief, the section 8 use declarations and accompanying specimens, filed in connection with both the section and 8 and 15 use and incontestability declarations in 2008 and later with the section 8 and 9 application for renewal filed in 2012, were

false when made, Registrant and its counsel knew such declarations and specimens to be false, but nevertheless made and filed them with the intent to deceive the US Trademark Office in order to maintain the registration of the mark, and each of such declarations were therefore fraudulent, rendering the registration invalid and subject to cancellation.

12. The continued maintenance of the registration sought to be cancelled on the Trademark Register places, and will continue to place, a cloud on the Petitioner's right to use the trademark BUGATTI for goods in International class 3.

WHEREFORE, Petitioner prays that this Petition for Cancellation be sustained in favor of Petitioner and that Registration No. 2606320 be cancelled.
