NOTICE OF NON-OPPOSITION

NOW COMES Registrant, M22, LLC, by and through its attorneys Revision Legal, PLLC, and for its Notice of Non-Opposition states the following:

I. FACTS AND ARGUMENT

On December 3, 2013, Petitioner filed its Petition to Cancel with the Trademark Trial and Appeal Board. In response, and on December 23, 2013, Registrant filed a Partial Motion to Dismiss, which asked the Board to dismiss the majority of Petitioner's claims for failure to state a claim on which relief can be granted. On January 13, 2014, Petitioner filed its Opposition to Registrant's Partial Motion to Dismiss and its Submission of Amended Petition for Cancellation Pursuant to Rule 15. Subsequently, on January 22, 2014, Registrant filed a reply to Petitioner's Opposition. On March 4, 2014, the Board issued an Order recognizing Petitioner's Opposition as a First Amended Petition to Cancel and Registrant's Reply as a renewed Motion to Dismiss Petitioner's Opposition. In its Order, the Board provided Petitioner with a period of fifteen (15) days from the date of mailing to file a brief in opposition to Registrant's

renewed Motion to Dismiss. Consequently, Petitioner's brief in opposition to Registrant's renewed Motion to Dismiss was due on March 20, 2014. Since Petitioner has not filed a brief in opposition to Registrant's Renewed Motion to Dismiss, Registrant hereby provides the Board with notice of Petitioner's failure to timely respond and respectfully requests that the Board grant Registrant's renewed Motion to Dismiss.
