PETITION FOR CANCELLATION

Under Armour, Inc. (“Under Armour”), believes that it is, and will continue to be, damaged by U.S. Reg. No. 4,315,559 for the designation PUPPY ARMOUR for “Clothing for domestic pets; Garments for pets; Pet clothing,” in Class 18 and hereby petitions for cancellation of the same. As grounds for its cancellation, Under Armour alleges the following, upon actual knowledge with respect to itself and its own acts, and upon information and belief as to other matters:

Under Armour, Its Products and Services, and Its Famous Trademarks

1. Opposer Under Armour is a Maryland corporation located at 1020 Hull Street, Baltimore, Maryland 21230.
2. Under Armour is one of the world’s most successful, popular, and well-known providers of performance apparel, footwear, sporting goods, and accessories. Through Under Armour’s innovative use of advanced engineering and technology, it has revolutionized the performance-product industry. In 2012 alone, Under Armour sold more than \$1.8 billion worth of products.

3. Since at least as early as 1996, Under Armour has continuously used and promoted (through itself, its predecessor in interest, and its licensees) the UNDER ARMOUR mark for apparel products.

4. Over the years, Under Armour has expanded to a wide range of other products and services, including but not limited to a full line of clothing, footwear, headwear, accessories, sports equipment, and bags. The distinctive UNDER ARMOUR mark has been used and promoted across Under Armour's extensive product line.

5. As part of its line, Under Armour has offered UNDER ARMOUR-branded backpacks, hiking bags, messenger bags, tote bags, wristlet bags, duffel bags, shoe bags, toiletry kits, and umbrellas.

6. Reflecting its significant growth and expansion over the years, Under Armour owns registrations and/or applications for its UNDER ARMOUR mark covering a wide array of products and services, including products/services in Classes 3, 5, 9, 10, 14, 16, 18, 21, 22, 24, 25, 26, 28, 32, 35, and 41.

7. In addition to its UNDER ARMOUR mark, Under Armour has used and promoted the ARMOUR mark alone and numerous other ARMOUR-formative marks in connection with its wide range of products and services, including, for example, ARMOUR ACCESS, ARMOUR ELITE, ARMOUR GRABTACK, and ARMOUR SELECT. These ARMOUR-formative marks have been used and promoted individually and/or as a family of ARMOUR marks.

8. Under Armour has sold billions of dollars worth of products under the UNDER ARMOUR mark and ARMOUR-formative marks (individually and collectively, the "ARMOUR Marks"). Under Armour's products are promoted, offered, and sold nationwide in connection

with the ARMOUR Marks through a wide variety of retail means, including but not limited to thousands of retail stores. These retail stores include national, regional, independent, and specialty retailers such as *Foot Locker, Finish Line, The Sports Authority, Dick's Sporting Goods, Modell's, Hibbett Sports, Nordstrom, and The Army and Air Force Exchange Service.*

9. Under Armour's products are also offered and sold in connection with its ARMOUR Marks through the websites and mail order catalogs of many of its retailers; Under Armour's own retail and factory UNDER ARMOUR stores; and Under Armour's websites, catalogs, and toll-free call center.

10. For years, Under Armour has spent tens of millions of dollars annually advertising and promoting its ARMOUR Marks and products to the general public. Under Armour has widely and extensively promoted its ARMOUR Marks and products through virtually every available type of media, including but not limited to print publications, signage, television, and/or the Internet.

11. With respect to print publications and signage, Under Armour has advertised and promoted its ARMOUR Marks and products in a wide variety of nationally circulated magazines and newspapers, including but not limited to *People, Cosmopolitan, Glamour, Men's Health, Runner's World, Sports Illustrated, ESPN the Magazine, Shape, Women's Health, The New York Times, The Washington Post, USA Today, The Los Angeles Times, and The Chicago Tribune.* Further, these marks have been featured on billboards and other signage in various cities, including but not limited to Baltimore, Philadelphia, and New York City.

12. Under Armour has advertised and promoted its ARMOUR Marks and products through television commercials, including a television commercial aired during the 2008 NFL Super Bowl, product placement in popular movies (such as the conclusion of the latest Batman

movie trilogy “The Dark Knight Rises”; Disney’s “The Rookie,” starring Dennis Quaid; Oliver Stone’s “Any Given Sunday,” starring Al Pacino and Jamie Foxx; “The Blind Side,” starring Sandra Bullock; and “The Replacements,” starring Keanu Reeves), national television programs (such as “Duck Commanders,” “Buck Commanders,” “Crush with Lee & Tiffany,” and “Friday Night Lights,” starring Kyle Chandler), video games, and coverage of sporting events featuring its branded products, among other means.

13. Under Armour also promotes and showcases its ARMOUR Marks and products on its websites, including Under Armour’s website at www.underarmour.com. In addition, Under Armour’s ARMOUR Marks and products are advertised and/or sold through many of its retailers’ websites, including but not limited to the websites used by *Eastbay*, *Nordstrom*, *The Sports Authority*, *Dick’s Sporting Goods*, and *Modell’s*, and third-party shopping websites such as amazon.com and ebay.com.

14. Sponsorships, outfitting agreements, and individual athlete agreements represent another significant form of advertising and promotion by Under Armour. Under Armour’s ARMOUR Marks are promoted through high-profile athletes and teams competing at the youth, collegiate, professional, and Olympic levels, e.g., master hunters Cameron Hanes, Lee and Tiffany Lakosky, Whitney Isenhart; the NFL’s Ray Lewis, Tom Brady, Brandon Jacobs, Miles Austin, Vernon Davis, Jason Pierre-Paul, and Anquan Boldin; the MLB’s Ryan Zimmerman, Jose Reyes, and Jonathon Papelbon; U.S. Olympic swimmer Michael Phelps; and next-generation stars Brandon Jennings (NBA), Cam Newton (NFL), and Bryce Harper (MLB).

15. In addition to its own substantial advertising and promotional activities, Under Armour and its ARMOUR Marks and products have received and continue to receive widespread unsolicited media coverage. Indeed, many of the athletes, teams, and sporting events

sponsored by Under Armour appear on nationally broadcast television programs and in widely circulated publications, exposing tens of millions of consumers to the ARMOUR Marks.

Moreover, Under Armour has received numerous awards for its commercial success in connection with the development of its innovative and technologically enhanced products.

16. As a result of the distinctive nature, and thus inherent strength, of the ARMOUR Marks as applied to Under Armour’s products; the widespread advertising, publicity, promotion, and sales of those marks and products; and Under Armour’s longstanding and extensive use of those marks, the ARMOUR Marks have been well known and famous for years.

17. In *Under Armour, Inc. v. Bode*, Opp. No. 91178653 (TTAB May 21, 2009), the Trademark Trial and Appeal Board of the United States Patent and Trademark Office (PTO) expressly acknowledged the fame of the UNDER ARMOUR mark.

18. Under Armour owns, among others, the following valid and subsisting U.S. trademark registrations for its UNDER ARMOUR marks (printouts of the current status and title of the registrations from the USPTO TSDR database are attached as Exhibit A), many of which are in the same class as the goods listed in Registration No. 4,315,559:

Count Two
Dilution, 15 U.S.C. § 1125(c)

28. Under Armour repeats and realleges each and every allegation set forth in Paragraphs 1 through 27.

29. Through extensive use and promotion, Under Armour's ARMOUR Marks are famous as defined under Section 43(c)(1) of the Lanham Act, as amended, 15 U.S.C. § 1125(c)(1).

30. Under Armour's ARMOUR Marks became famous before Registrant's August 1, 2011 claimed date of first use and its August 22, 2011 filing date.

31. Registrant's PUPPY ARMOUR designation so resembles Under Armour's famous ARMOUR Marks that it is likely to dilute the distinctive quality of Under Armour's ARMOUR Marks under Section 43(c) of the Lanham Act, as amended, 15 U.S.C. § 1125(c).

WHEREFORE, Under Armour believes that it will continue to be damaged by the registration of the mark shown in U.S. Reg. No. 4,315,559 and respectfully requests that the Petition for Cancellation be sustained and that U.S. Reg. No. 4,315,559 be cancelled.





**REQUIREMENTS TO MAINTAIN YOUR FEDERAL
TRADEMARK REGISTRATION**

**WARNING: YOUR REGISTRATION WILL BE CANCELLED IF YOU DO NOT FILE THE
DOCUMENTS BELOW DURING THE SPECIFIED TIME PERIODS.**

Requirements in the First Ten Years*

What and When to File:

First Filing Deadline: You must file a Declaration of Use (or Excusable Nonuse) between the 5th and 6th years after the registration date. *See* 15 U.S.C. §§1058, 1141k. If the declaration is accepted, the registration will continue in force for the remainder of the ten-year period, calculated from the registration date, unless cancelled by an order of the Commissioner for Trademarks or a federal court.

Second Filing Deadline: You must file a Declaration of Use (or Excusable Nonuse) **and** an Application for Renewal between the 9th and 10th years after the registration date.*
See 15 U.S.C. §1059.

Requirements in Successive Ten-Year Periods*

What and When to File:

You must file a Declaration of Use (or Excusable Nonuse) **and** an Application for Renewal between every 9th and 10th-year period, calculated from the registration date.*

Grace Period Filings*

The above documents will be accepted as timely if filed within six months after the deadlines listed above with the payment of an additional fee.

**The United States Patent and Trademark Office (USPTO) will NOT send you any future notice or
reminder of these filing requirements.**

***ATTENTION MADRID PROTOCOL REGISTRANTS:** The holder of an international registration with an extension of protection to the United States under the Madrid Protocol must timely file the Declarations of Use (or Excusable Nonuse) referenced above directly with the USPTO. The time periods for filing are based on the U.S. registration date (not the international registration date). The deadlines and grace periods for the Declarations of Use (or Excusable Nonuse) are identical to those for nationally issued registrations. *See* 15 U.S.C. §§1058, 1141k. However, owners of international registrations do not file renewal applications at the USPTO. Instead, the holder must file a renewal of the underlying international registration at the International Bureau of the World Intellectual Property Organization, under Article 7 of the Madrid Protocol, before the expiration of each ten-year term of protection, calculated from the date of the international registration. *See* 15 U.S.C. §1141j.
