JOINT MOTION FOR STIPULATED RESET OF DEADLINE

and believe that additional time to focus on such settlement would be beneficial.

5. Respondent and Petitioner have agreed to, and request the Board's approval of, a stipulation resetting the deadline for the parties to make Initial Disclosures to each other pursuant to TBMP § 401.02 and 37 CFR § 2.120(a) from Friday, May 9, 2014 to Monday, May 19, 2014.

6. Respondent and Petitioner have not agreed to, and do not request at this time, any extension or reset of any other deadline set forth in the Institution Order.


