WITHDRAWAL OF CANCELLATION PROCEEDING

Petitioner Integrated Voting Solutions, Inc. (“Petitioner”), by their attorneys, hereby moves for withdrawal of the cancellation proceedings pursuant to 37 CFR § 2.114(c). The cancellation proceeding was suspended by agreement of the parties before Advanced Ballot Solutions, LLC’s (“Respondent”) time to answer, pending the outcome of a simultaneous case between the same parties before the United States District Court for the Eastern District of California. The cancellation has remained suspended since that time, and therefore the time for Respondent to file an answer has not yet come to pass, and accordingly no answer has been filed.
