**JOINT MOTION TO SUSPEND PROCEEDINGS PURSUANT TO 37 C.F.R. 2.117**

Bullets2Bandages LLC (“B2B”) and Caliber Corporation (Caliber) respectfully submit this motion for suspension of proceedings pending the completion of the civil action between B2B and Caliber before the Honorable Cathy A. Bencivengo, in the United States District Court, Southern District of California, Case No. 13CV3134CAB-BLM, commenced on December 20, 2013.

This request is made for good cause and in good faith and is made with the express consent of Joseph T. Nabor, counsel for Petitioner, to this Motion to Suspend Proceedings.

Pursuant to 37 C.F.R. § 2.117(a), “proceedings before the Board may be suspended until termination of the civil action” whenever “it shall come to the attention of the Trademark Trial and Appeal Board that a party or parties to a pending case are engaged in a civil action or another Board proceeding which may have a bearing on the case.” *See* TMBP § 510.02(a); *Gen. *Assocs. Inc.*, 179 U.S.P.Q. 861 (TTAB 1973); *Whopper-Burger, Inc. v. Burger King Corp.*,  
171 U.S.P.Q. 805 (TTAB 1971).

The parties respectfully request that the Board grant this motion and suspend this  
cancellation proceeding pending disposition of the district court action.
