**MOTION TO SUSPEND**

Pursuant to TBMP § 510.03(a), Petitioner, Bandersnatch Group, Inc., and Registrant, Nova Gaming, LLC (d/b/a Nova Technologies, LLC), respectfully request a 90-day suspension of the above-captioned cancellation proceeding to allow the parties adequate time to conclude an amicable resolution of their trademark dispute. 




