4. Upon information and belief, Registrant's non-use and/or discontinuance of use in commerce of Registrant's Mark was with the intent not to resume such use.


5. Upon information and belief, Registrant has abandoned Registrant's Mark in U.S. Reg. No. 3,845,512.


