**PETITIONER’S CONSOLIDATED MOTION FOR LEAVE TO FILE
FIRST AMENDED PETITION TO CANCEL AND FOR EXTENSION OF DISCOVERY
AND TRIAL DATES**

Petitioner Hot Topic Merchandising, Inc. (“Petitioner” or “Hot Topic”) hereby moves the Trademark Trial and Appeal Board (the “Board”) for leave to file a First Amended Petition to Cancel, a copy of which is attached hereto as Exhibit A. Petitioner also requests that the Board extend the discovery and trial dates in this matter. The original Petition to Cancel was filed *pro se*. Petitioner recently retained the undersigned counsel, and the Amended Petition, prepared by the undersigned counsel, includes more detailed allegations to support the grounds for cancellation asserted in the original Petition. Accordingly, Petitioner seeks the Board’s leave to amend, which should be granted for the reasons set forth below.

STATEMENT OF FACTS

1. Petitioner filed its Petition to Cancel on October 28, 2014. The Petition was signed by a non-officer employee of Petitioner, which Defendant noted in his Answer, filed on November 28, 2014.

2. The Board's scheduling order for this proceeding provided that the Discovery Conference should be held by December 27, 2014. The parties have not yet held a Discovery Conference, although several communications have been exchanged between counsel in an attempt to do so, as recently as January 12, 2015.

3. On January 9, 2015, Hot Topic retained the undersigned counsel to represent it in these proceedings.

4. In light of the recent engagement of the undersigned counsel, Petitioner requests that the discovery and trial dates in this matter be extended, commencing with extension of the Discovery Conference to ten (10) days from the date of Defendant's filing of the Answer to the Amended Petition.

5. On January 12, 2015, the undersigned reached out to counsel for Defendant by telephone, followed up by email of the same date, to introduce counsel and attempt to obtain Defendant's consent to the filing of the Amended Petition, and extension of discovery and trial dates. The undersigned counsel sent another follow-up email on January 20, 2015, but, to date, has not heard back from Defendant's counsel.

ARGUMENT

Pursuant to Federal Rule of Civil Procedure 15(a) and Section 507.01 of the TBMP, leave to amend a pleading should be freely given when justice so requires. The Board grants leave to amend pleadings when justice so requires, unless entry of the proposed amendment would violate settled law or be prejudicial to the rights of the adverse party. TBMP § 507.02. Petitioner submits that permitting it to amend its Petition to Cancel will not prejudice the Defendant and that this Motion is timely insofar as the parties have not held a Discovery Conference or conducted any discovery.

To begin with, because the Petition to Cancel was not signed by an attorney or authorized officer of Petitioner, the Board should properly consider the Petition when a new copy, signed by an authorized person entitled to practice before the U.S. Patent and Trademark Office in trademark cases, is filed. TBMP § 114.06. As explained above, Petitioner recently retained counsel. Counsel has reviewed the original Petition and has determined that it is appropriate to amend the Petition. Accordingly, counsel has prepared an Amended Petition that includes more detailed allegations to support the grounds for cancellation asserted in the original Petition.

For example, the Amended Petition includes information about the emails that Defendant sent to Petitioner, the contents of Defendant's Facebook® page, evidence of use of the subject mark by third parties on the Internet, and the contents of trademark applications Defendant filed with the USPTO. None of these allegations can be considered unfairly prejudicial to the rights of Defendant. Defendant has first-hand knowledge of these allegations, except perhaps the evidence of third-party use of the subject mark, which in any event the Defendant could find through its own search of the Internet, if it has not done so already. In short, the Amended Petition does not set forth any new claims or raise any new legal theories.

In addition, allowing Petitioner to amend its Petition is consistent with the Board's policy that encourages parties to be represented by counsel in proceedings before the Board. As stated in Section 114.01 of the TBMP, "because the governing practices and procedures in proceedings before the Board are quite technical and highly specialized, it is strongly recommended that an attorney familiar with trademark law represent a party."

Finally, the interests of justice and judicial economy will undoubtedly be served by having Petitioner's claims supported by all pertinent allegations. By allowing Petitioner to

amend its Petition to Cancel to amplify the allegations supporting its claim, the Board is enabling a full adjudication of the merits of this dispute.

Request for New Discovery and Trial Dates

In addition, Petitioner respectfully requests that the Board enter a new date for the parties to conduct a Discovery Conference, extended to ten (10) days after Defendant responds to the Amended Petition, or ten (10) days after the instant Motion is granted, whichever is later, and extend all other discovery and trial dates accordingly.

WHEREFORE, Petitioner respectfully requests that the Board grant this Consolidated Motion for Leave to File the attached First Amended Petition for Cancellation and Motion to Extend Discovery and Trial Dates.

FIRST AMENDED PETITION TO CANCEL

Petitioner Hot Topic Merchandising, Inc. ("Petitioner" or "Hot Topic") believes that it is or will be damaged by the continued registration of the mark shown in Registration No. 4,447,800 and by and through the undersigned counsel, hereby submits its First Amended Petition to Cancel that registration in its entirety against Registrant Christopher Cline ("Registrant" or "Cline"):

1. Petitioner Hot Topic is a California corporation with a principal business address of 18305 E. San Jose Avenue, City of Industry, California 97148.
2. Upon information and belief, Registrant Cline, an individual who is a citizen of the United States with an address of 2336 Northumbria Drive, Sanford, Florida 32771 is the owner of the mark MAYBE PARTYING WILL HELP (the "Mark") in Class 25 in U.S. Reg. No. 4,447,800 (the "'800 Registration").
3. Petitioner owns a chain of retail stores that sell a variety of clothing and accessories. Petitioner also sells its clothing and accessories online on the website www.hottopics.com. Petitioner has used the phrase "maybe partying will help" decoratively on articles of clothing. Pages from Petitioner's website offering to sell shirts displaying the phrase



MAYBE PARTYING WILL HELP are enclosed as Exhibit 1. The phrase is used for ornamentation on Petitioner's products and is not used as a trademark or source indicator for Petitioner's goods.

4. In an email dated September 25, 2014, Registrant asserted his '800 Registration against Petitioner, claiming that Petitioner's use of the phrase "maybe partying will help" on its goods infringed the '800 Registration. In the email Registrant "formally" notified Petitioner of its infringement and of his "intent to seek any and all relief available to me as the registered owner of the mark." A copy of the September 25, 2014 email is attached as Exhibit 2.

5. Registrant sent another email dated October 1, 2014, alleging that Petitioner was infringing the '800 Registration. A true and correct copy of the October 1, 2014 email is attached as Exhibit 3. In the second email, Registrant stated he was "open to a wide array of remedies including a generously broad licensing arrangement."

6. Registrant applied to register the mark MAYBE PARTYING WILL HELP on April 30, 2013, claiming use of the mark in commerce since March 1, 2011, for "Hooded sweat shirts; Long-sleeved shirts; Open-necked shirts; Shirts and short-sleeved shirts; Short-sleeved or long-sleeved t-shirts; Short-sleeved shirts; Sleep shirts; Sweat shirts; T-shirts; T-shirts for casual outings; Tee shirts; Wearable garments and clothing, namely, shirts; Women's clothing, namely, shirts, dresses, skirts, blouses" in Class 25. This application matured into the '800 Registration on December 10, 2013.

First Basis for Cancellation -- Failure to Function as Trademark

7. Upon information and belief, Registrant was not using MAYBE PARTYING WILL HELP as a trademark for the goods listed in the '800 Registration at the time he applied to register the mark, and has not used it as a trademark at any time. Instead, Registrant, at the time

of application for the Mark, and since, has used the phrase MAYBE PARTYING WILL HELP as mere ornamentation on T-shirts. In his trademark application for the '800 Registration, Registrant represented that his website address was www.maybepartyingwillhelp.com. Attached as Exhibit 4 is a true and correct copy of a Facebook® page for www.maybepartyingwillhelp.com showing a photograph of a T-shirt emblazoned with the phrase "MAYBE PARTYING WILL HELP."

8. The phrase MAYBE PARTYING WILL HELP is commonly used decoratively on clothing. Attached as Exhibits 5a-5d are true and correct copies of webpages of third parties offering to sell shirts decorated with the phrase MAYBE PARTYING WILL HELP.

9. Accordingly, the '800 Registration should be cancelled as void *ab initio* for Registrant's use of MAYBE PARTYING WILL HELP as merely a decorative or ornamental feature of Registrant's clothing that does not function as a trademark to identify the source of Registrant's goods.

Second Basis for Cancellation -- Fraud

10. As a further basis for cancellation of the '800 Registration, on April 30, 2013, Registrant filed with the U.S. Trademark Office an application which included a sworn declaration signed under penalty of perjury.

11. Registrant swore in his Declaration that, as of April 30, 2013, he was using the trademark MAYBE PARTYING WILL HELP in commerce on or in connection with all goods listed in the application. Upon information and belief, such statements were false at the time they were made. In particular, upon information and belief, Registrant had not made use of the mark MAYBE PARTYING WILL HELP in commerce on all of the goods identified in the '800

Registration, including in particular on “women’s clothing, namely shirts, dresses, skirts, blouses” and possibly all of the goods recited in the ‘800 Registration.

12. Registrant made such false statements about use of the mark on all the goods although the mark was not used on all the goods, with the intention to deceive the USPTO. Without Registrant's fraudulent statements, the ‘800 Registration would not have been issued by the USPTO.

13. Upon information and belief, Registrant has a history of filing applications tainted by deceptive and/or fraudulent statements as evidenced by Registrant's registration for the mark HOUSE MUSIC LOVES ME BITCH registered under Reg. No. 4,447,815 (the “‘815 Registration”). Registrant filed an application to register the mark HOUSE MUSIC LOVES ME BITCH on February 14, 2012 for T-shirts in Class 26. In that application, Ser. No. 85/542,868, Registrant filed a specimen showing a photograph of a T-shirt emblazoned with the phrase “HOUSE MUSIC LOVES ME BITCH.” A copy of the specimen is enclosed as Exhibit 6. An Office Action was issued on the application on May 25, 2012, refusing to register the mark on the grounds that “the mark, as used on the specimen of record, is merely a decorative or ornamental feature of applicant’s clothing; it does not function as a trademark to identify the source of applicant’s clothing and distinguish applicant’s clothing from that of others.” Registrant did not respond to the Office Action, and the application abandoned.

14. Instead, Registrant filed a new application, Serial No. 85/920,778, for HOUSE MUSIC LOVES ME BITCH, on May 1, 2013, for the following goods in Class 25: “Hooded sweat shirts; Long-sleeved shirts; Night shirts; Shirt fronts; Shirts; Shirts and short-sleeved shirts; Shirts for infants, babies, toddlers and children; Shirts for suits; Short-sleeved or long-sleeved t-shirts; Short-sleeved shirts; Sleep shirts; Sweat shirts; T-shirts; T-shirts for men,

women and children consisting of words, phrases and/or graphics which are suitable for social events, namely, concerts, parties and casual encounters; Tee shirts; Wearable garments and clothing, namely, shirts; Women's clothing, namely, shirts, dresses, skirts, blouses; Yoga shirts.” In this second application, Registrant filed as a specimen a photograph of the back of a T-shirt showing the “HOUSE MUSIC LOVES ME BITCH” in small type at the neck of the shirt. However, on information and belief, Registrant continued to use the phrase HOUSE MUSIC LOVES ME BITCH decoratively or ornamentally on T-shirts. Accordingly, Registrant obtained registration of the '815 Registration by fraud.

15. Upon information and belief, Registrant has adopted a business strategy of asserting trademark ownership for slogans used for ornamental purposes on T-shirts. Attached as Exhibit 7 is a true and correct copy of a screenshot from Registrant's Facebook page showing, respectively, T-shirts with the phrases “WE MUST PROTECT THIS HOUSE TM” and “DISCO BITCH TM” featured prominently on the front of the shirts as ornamental and decorative. By using the trademark symbol TM with slogans, Registrant is attempting to assert trademark ownership of popular slogans commonly used for ornamental purposes on clothing. Upon information and belief, upon asserting trademark ownership of popular slogans, Registrant attempts to force third parties to cease using these popular slogans decoratively on clothing or to pay a license fee to Registrant to continue to use such slogans.

Third Basis for Cancellation -- Abandonment

16. Alternatively, to the extent Registrant ever made lawful trademark use of MAYBE PARTYING WILL HELP as a valid trademark in connection with all the goods listed in the '800 Registration, upon information and belief, Registrant has ceased using the mark in

connection with all those goods and there is no evidence of any intent to resume use of the mark in connection with those goods.

WHEREFORE, Petitioner Hot Topic Merchandising, Inc. prays that Registrant Cline's mark Registration No. 4,447,800 be cancelled pursuant to 15 U.S.C. § 1064(3) because: (1) Registrant is not using the mark as a valid trademark; (2) Registrant obtained the '800 Registration by means of fraudulent representations to the Trademark Office; and (3) Registrant has abandoned the Mark.
