PETITION FOR CANCELLATION

Petitioner Wild About Beauty Limited (“Petitioner”), a United Kingdom private limited liability company having its principal place of business at 132-134 Lots Road London, SW10 0RJ United Kingdom, believes it is and will continue to be damaged by Registration No. 4,155,555 (“555 Reg.”), and hereby petitions to cancel the same under the provision of 15 U.S.C. §1064(3). As grounds for cancellation, Petitioner alleges that:

1. Petitioner is the owner of United States Trademark Application No. 79/134,825 (the "Application") for the mark WILD ABOUT BEAUTY, in connection with "*Cosmetic products in the form of aerosols for skincare; skin cleansers, skin toners, exfoliants for skin, skin moisturizers and beauty masks; non medicated skin creams, lotions and gels; pre-moistened cosmetic wipes; soaps; shampoos, hair conditioners, hair colourants, hair lotions, hair styling preparations; cosmetics; make up; eye shadow, lipsticks, foundation and blusher; non medicated toiletry preparations and substances; cotton buds for cosmetic purposes, cotton sticks for cosmetic purposes, cotton wool balls for removing cosmetics*" in International Class 3. The filing date of the Application is June 20, 2012. The print-out of the Trademark Status & Document Retrieval ("TSDR") Status Page from the United States Patent and Trademark Office ("USPTO") online database for the said Application is attached hereto as Exhibit 1.

2. Per the TSDR records, the current owner of the '555 Reg. is Camie Kypke (DBA Wild About Skin), an individual with a mailing address at 7325 Western Plains Ave, Abilene, Texas 79606.

3. On information and belief, Camie Kypke is the founder and managing member of Wild About You, LLC, (the "Company"), a Texas limited liability company with a principle place of address at 7325 Western Plains Ave, Abilene, Texas 79606, which is believed to be Camie Kypke's residence.

4. On information and belief, the current owner of '555 Reg. might be the Company because pursuant to the records of the USPTO, the Company claimed ownership of the '555 Reg. at the filing of the application to register another mark, the WILD ABOUT HAIR mark, U.S. Serial No. 85/647,007, which was registered as U.S. Registration No. 4,279,440. However, the USPTO records do not reveal any recordation of assignment or transfer of the ownership of the '555 Reg. to the Company.

Hereinafter, Ms. Kypke and the Company shall be referred to as the “Registrant” of the ‘555 Reg. unless the context suggests otherwise.

5. According to the TSDR records, the Registrant obtained the ‘555 Reg. for the mark WILD ABOUT SKIN, (the “Mark”) which issued on June 5, 2012 for “*Cosmetics for skin and body rejuvenation, namely, lotions for skin and body, toners, body scrubs, beauty serums, skin moisturizers, face and body creams, body balms, oils for cosmetic purposes, body and face powders, foundations, beauty gels, body butters, non-medicated ointment for treatment of sunburn, moisturizing solutions for the skin, body and facial masks, blush, eye shadows, lip stick, body polish, soaps, body sprays, shampoos, nail care preparations, conditioner, hair mousse, non-medicated lip care preparations, exfoliant creams, bath salts, bubble bath, oil baths for hair care, lip glosses, nail polish removers, skin cleansers, eye liners, lip liners, mascara, make-up mineral powders, skin bronzers, lip primers, facial concealers, eyelash tints, body sprays, pomades, seals, foams, cosmetic sunscreen preparations, sun block, body wash, hair rinses, nail lacquers, pre-moistened cosmetic towelettes, cosmetic pads, cosmetic preparations for skin care*”. The filing date of the ‘555 Reg. is May 19, 2011, prior to the filing date of the Application. The claimed date of first use of the Mark is February 6, 2012. The print-out of the TSDR Status Page from the USPTO online database for the said registration is attached hereto as Exhibit 2.

6. According to the USPTO’s records, Registrant claims that it began selling or transporting the goods described in the ‘555 Reg. under the Mark in interstate commerce on February 6, 2012.

7. Petitioner has standing and is damaged by the existence of the ‘555 Reg. because registration of its Application has been refused on the grounds that it is likely to cause confusion with the ‘555 Reg. under Trademark Act Section 2(d), 15 USC §1052(d). Said refusal was made “final” and was issued by the USPTO effective July 7, 2014. Continued registration of the Mark creates statutory rights in Registrant in

violation and derogation of the rights of Petitioner, resulting in harm, detriment, and damage to Petitioner.

8. In the final office action, the Petitioner's Application was also refused on the grounds of likelihood of confusion with U.S. Registration No. 4,279,440 for WILD ABOUT HAIR. Petitioner is simultaneously initiating a separate cancellation proceeding against U.S. Registration No. 4,279,440. Petitioner reserves its right to consolidate these two cancellation proceedings at a later stage.

**CLAIM ONE: ABANDONMENT**

9. Petitioner hereby incorporates by reference the preceding paragraphs as if they were fully set forth herein.

10. Prior to initiating this proceeding, the Petitioner conducted an investigation directed to Registrant's use of the Mark, including, inter alia, a review of its websites at [camiekypke.com](http://camiekypke.com), [camiek.com](http://camiek.com), and [wildabouts.com](http://wildabouts.com).

11. Petitioner was unable to locate any evidence that the Mark was currently being used or had ever been used in commerce in connection with any of the goods claimed in the '555 Reg.

12. On information and belief, Registrant has either never used the Mark in commerce in connection with any of the goods listed in the '555 Reg. or, to the extent the Mark was ever used, has discontinued use of the Mark in commerce with no intent to resume such use, thus abandoning the Mark and rendering the '555 Reg. subject to cancellation.

**CLAIM TWO: FRAUD ON THE TRADEMARK OFFICE**

13. Petitioner hereby incorporates by reference the preceding paragraphs as if they were fully set forth herein.

14. On information and belief, Registrant filed a Statement of Use with the USPTO for the Mark on March 15, 2012 for the application to register the Mark. The Statement of Use was signed by the Registrant's attorney of record, Matthew H. Swyers,

on behalf of the Registrant on March 15, 2012 and represented to the USPTO that Registrant was using the Mark in commerce in connection with all goods listed in the application namely, "*Cosmetics for skin and body rejuvenation, namely, lotions for skin and body, toners, body scrubs, beauty serums, skin moisturizers, face and body creams, body balms, oils for cosmetic purposes, body and face powders, foundations, beauty gels, body butters, non-medicated ointment for treatment of sunburn, moisturizing solutions for the skin, body and facial masks, blush, eye shadows, lip stick, body polish, soaps, body sprays, shampoos, nail care preparations, conditioner, hair mousse, non-medicated lip care preparations, exfoliant creams, bath salts, bubble bath, oil baths for hair care, lip glosses, nail polish removers, skin cleansers, eye liners, lip liners, mascara, make-up mineral powders, skin bronzers, lip primers, facial concealers, eyelash tints, body sprays, pomades, seals, foams, cosmetic sunscreen preparations, sun block, body wash, hair rinses, nail lacquers, pre-moistened cosmetic towelettes, cosmetic pads, cosmetic preparations for skin care*" in International Class 3.

15. On information and belief, including based on the investigation described above, at the time of filing of the Statement of Use, Registrant was not using the Mark in commerce in connection with any of the listed goods in the application, and Registrant's representation was false.

16. A declaration of use, such as the allegedly false Statement of Use described above, is a prerequisite to issuance of a registration. Thus, the misrepresentation described above was material to the registrability of the Mark.

17. At the time it made its declaration, Registrant must have been aware that it was not using the Mark in commerce in connection with the goods listed in the application.

18. On information and belief, Registrant had knowledge of the falsity of its representation and made the alleged misrepresentation with intent to deceive the USPTO to obtain a registration.

19. On information and belief, in reliance to Registrant's false representation, the USPTO registered the Mark for the goods listed in the '555 Reg.

**WHEREFORE**, Petitioner prays that this Petition for Cancellation be sustained in favor of Petitioner, and Registration No. 4,155,555 be canceled in whole or in applicable part.
