**STIPULATION TO EXTEND DISCOVERY DEADLINE**

Pursuant to TTAB Rule 403.04 and TBMP § 501.03, the Parties hereby agree and stipulate, for good cause and through their undersigned counsel, to extend the closing date for discovery from November 14, 2015 to February 14, 2016. “The resetting of the closing date for discovery will result in the rescheduling of pretrial disclosure deadlines and testimony periods without action by any party.” 37 C.F.R. § 2.121(a). As a matter of course, the Parties request the Board to reset the deadline for expert disclosure contemporaneous with the extension of the closing date for discovery.

Because of an extraordinary volume of motion practice, other tight discovery deadlines, and complex litigation matters, not including the numerous other unrelated matters requiring immediate attention of counsel, the Parties agree to extend the current closing date for discovery

to February 14, 2016. Granting this stipulation will allow the Parties time necessary to complete discovery without further prejudicing the status of the present action.
