On April 1, 2015, pursuant to Trademark Rule 2.117(a), Trademark Trial and Appeal Board Manual of Procedure (“TBMP”) § 510.02(a), The DEW, LLC dba Undie Run, filed a motion (“Registrant’s Motion”) to suspend this proceeding, pending disposition of Civil Action No. 1:15-cv-00348, *Cupid Charities, Inc. v. 2. *Cupid Charities, Inc. v. The Dew, LLC*, Petition for Cancellation No. 92060918 (T.T.A.B. Filed Feb. 18, 2015)

For the foregoing reasons, Petitioner consents to Registrant's request to suspend this proceeding and respectfully requests suspension of this Petition for Cancellation, pending the outcome of the Pending Action.
