NOTICE OF SETTLEMENT

Plaintiff HIMG Seramik Ve Medikal Kompozit San. Tic. Ltd. Sti. (hereinafter "Plaintiff") respectfully submits this Notice of Settlement and Motion to Dismiss, and informs the Trademark Trial and Appeal Board as follows:

(1) The Parties have reached an agreement to resolve the claims, counterclaims, and cross-claims in the Case No.: 3:14-cv-02274-JAH-RBB before United States District Court, Southern District of California, which were memorialized in a confidential settlement agreement executed by Plaintiff on January 1, 2016 and Defendants on December 31, 2015 (the "Settlement Agreement").

(2) Accordingly, the Parties have decided to cancel the TTAB Proceeding Number 92061129, with ESTTA Tracking Number ESTTA667079.

(3) The accompanying Request for Dismissal reflects the Parties' intent to dismiss the cancellation proceeding and all pertinent actions.

(4) Accordingly, there is no need for the Trademark Trial and Appeal Board to further consider or rule on the Petition to Cancel, and the TTAB Proceeding Number 92061129 should therefore be terminated.
