Notice of Correction of Electronically Generated Grounds for Cancellation

Petitioner hereby submits this Notice of Correction to notify the Trademark Trial and Appeal Board (“Board”) that Petitioner inadvertently selected the wrong grounds for cancellation while filing the Petition for Cancellation using the Electronic System for Trademark Trials and Appeals (“ESTTA”) online form. Specifically, Petitioner mistakenly selected Trademark Act Section 2(b) (“Consists of or comprises the flag or coat of arms or other insignia of the United States, or of any State or municipality, or of any foreign nation, or any simulation thereof”) and Trademark Act Section 2(c) (“Consists of or comprises a name, portrait, or signature of a living individual without written consent, or the name, portrait, or signature of a deceased president without the written consent of the surviving spouse”) as the grounds for cancellation on the ESTTA form. In fact, as noted in the Petition for Cancellation as filed, Petitioner’s grounds for cancellation are as follows:

- Registration Procured by Fraud under 15 U.S.C. § 1064(3);
 - Lack of *Bona Fide* Use of the Y.L.SKIN Mark In Commerce under 15 U.S.C. § 1051(a);
- and

- Abandonment based on Non-Use under 15 U.S.C. §1064(3).

Petitioner believes the filing of this Notice of Correction to be sufficient to rectify the inadvertently checked boxes in the ESTTA form.
