**PETITIONER'S RESPONSE AND CONSENT TO  
RESPONDENT'S MOTION TO AMEND REGISTRATION**

Pursuant to Trademark Rule 2.133, Petitioner StrongVolt ("StrongVolt") hereby consents to Respondent Matey Michael Ghomeshi's ("Ghomeshi") Motion to Amend Registration to amend the description of goods of Registration No. 3,798,681 (the "'681 Registration"). On April 25, 2016, Ghomeshi filed a Motion to Amend Registration without asking for StrongVolt's consent to amend the registration. StrongVolt hereby consents to Ghomeshi's removal of the following goods from the '681 Registration: "portable electronic devices for recording, organizing, transmitting, manipulating and reviewing text, data, image and audio files; audio-video media players for automobiles; audio and video recorders; digital video and event recorders that activate from automotive impact; transmitters for video signals for transmission over twisted pair cables." StrongVolt agrees that the description of the goods listed in the '681 Registration will now include only "audio speakers for computers, analog and digital audio signal transmitters." StrongVolt's consent to Ghomeshi's Motion to Amend Registration shall

not be interpreted as to conceding on the issue of validity of the remaining goods listed in connection with the '681 Registration.
