PETITION FOR CANCELLATION

Petitioner, LOUIE YU, an individual, with an address at 18455 Burbank Blvd, #110, Tarzana, California 91356, believes he will be damaged by the continued registration of a service mark for instructional and educational services, namely, conducting classes in the field of martial arts (International Class 41) (hereinafter "Mark") shown in Registration no. 2,167,035 (hereinafter "Registration"), registered on June 23, 1998, for which the owners of record are: Carmen Rebecca de Thouars; Carmen Suzanne Miller; and Danny Andrew Huybrechts, all

individuals (hereinafter "Respondents"). Petitioner petitions to cancel said Registration in accordance with 37 CFR § 2.111(b).

COUNT I

FRAUD

1. On November 25, 1996, a federal trademark application (serial no. 75/203,916) for the Mark was filed that eventually matured into the above registration on June 23, 1998. The registrant was Mr. Paul de Thouars, PDT Academy, 616 E. Live Oak Ave., Arcadia CA 91006.

2. On January 19, 2011, Mr. de Thouars signed a letter (**Exhibit A**) addressed to Mr. Danny Huybrechts stating that Mr. Huybrechts was no longer a "lineage holder of PDT Pukulan Pentjak Silat Sera nor the Lineage holder of PDT Pukulan Pentjak Silat Bukti Negara," and that Mr. Huybrechts had "declined to be the head of the board of PDT Pukulan Pentjak Silat Bukti Negara." The letter further states that "all rights, privileges, names, trademarks and copyrights are assigned to the Board of Directors of Sera. The current trademarks and word marks of PDT Pukulan Pentjak Silat Bukti Negara and PDT Pukulan Pentjak Silat Sera shall be in the possession of the Board of Directors of Sera."

3. On September 30, 2011, Mr. de Thouars signed a letter (**Exhibit B**) naming the Board of Directors. Mr. Louie Yu, the Petitioner is listed as a Board member, but none of the Respondents are listed as Board members. The letter further states "I will entrust my full authority to them upon my passing."

4. On September 10, 2013, Mr. Paul de Thouars died in Riverside County, California.
5. On July 21, 2014, a trademark assignment was recorded (**Exhibit C**). The assignment transfers ownership of the Mark to the Respondents.
6. However, the January 19, 2011, letter expressly assigned ownership of the Mark to the Board of Directors. None of the Respondents are named as Board members.
7. Because the Respondents assigned ownership of the Mark to themselves, in direct contradiction to the express directions of the Mark's registrant, the Respondents committed fraud.

COUNT II

ABANDONMENT

8. Upon information and belief, neither Carmen Rebecca de Thouars nor Carmen Suzanne Miller, two of the Respondents, have ever offered, or performed the services of conducting classes in the field of martial arts under the Mark.
9. Mr. Danny Huybrechts, the third Respondent, is offering the services of conducting classes in the field of martial arts, but is not using the Mark (**Exhibit D**). Exhibit D is the "Home" page of Mr. Huybrechts' Internet web site. The Mark is not displayed in connection

with the offered martial arts services on the "Home" page, nor is the Mark displayed on any of the other pages on the site.

10. Instead, Mr. Huybrechts is using a different mark in connection with the offered martial arts services (**Exhibit E**). Exhibit E is shown on the "Home" page of Mr. Huybrechts' Internet web site, and displays a different mark that uses a different design and different words than the Mark. The words shown under the different design are "Pukulan Pentjak Silat Semangat Baru." The words in the Mark are "Pentjak Silat Bukti Negara." The design in the mark Mr. Huybrechts is using shows a triangular shaped element having a red border with a dark interior. A yellow star is located at each corner of the triangle, with two dark brown crossed knives located underneath the star located at the uppermost corner of the triangle, and a branch of green leaves located on either side of the uppermost corner. A stylized bird with a yellow beak and light brown feathers is located substantially within the triangle, with a yellow diamond-shaped element located over the bird's body, and two crossed swords and a knife with a curved blade located over the diamond-shaped element. A striped tiger with arms outstretched and claws extended is positioned at the base of the triangle. Two vertical bamboo elements are located on either side of the tiger's shoulders and beneath the tiger the words "Pukulan Pentjak Silat Semangat Baru" are displayed in a yellow banner.

In contrast, the Mark comprises a circle, with a stylized bird located within the circle, the bird grasping a sword in each talon. Tail feathers extend downward between the talons. A tiger's face is located over the bird's body, with the underlined words "Pentjak Silat Bukti Negara" located around the lower portion of the circle, the underline extending past either end of the words. Respondent's design does not include tail feathers, nor talons. In addition,

Respondent's stylized tiger has arms and claws, which are not found in the Mark. Clearly, the design Mr. Huybrechts is using in connection with the offered martial arts services is very different from the Mark.

11. Because none of the Respondents are using the Mark in commerce in connection with the listed services, and upon information and belief, do not intend to use the mark, and have not used the Mark in commerce in connection with the listed services for at least the last three years, the Mark is abandoned.

WHEREFORE, Petitioner deems it is, and will be damaged by the Trademark Registration No. 2,167,035, and requests that the instant Petition to Cancel be granted and that the aforesaid registration be canceled.

To: Danny Huybrechts

I, Paul De Thouars, commonly known as Pendekar Paul de Thouars am currently the only guru of Pukulan Pentjak Silat Sera (Serak) in the John De Vries lineage.

I am the only lineage holder to the traditional art of Sera which was bestowed upon my by my late uncle, teacher and previous lineage holder John De Vries also known as uncle John De Vries.

In being the only lineage holder and consequently the only guru of Pukulan Pentjak Silat Sera with teaching authority under John De Vries, I here by proclaim there will be no single lineage holder and guru upon my passing.

I have appointed a board of directors of senior students. These appointed students will be responsible for upholding the traditional art of Pukulan Pentjak Silat Sera curriculum and its teaching both physical, moral and spiritual. These students have shown their courage, loyalty and unwavering integrity as practitioners of Sera as well as people in general.

I declare, upon my passing, the sole and only authority of the traditional art of Paul De Thouars Pukulan Pentjak Silat Sera/Serak shall be the Board of Directors of Sera. No one shall have the rights or authority to teach the art of Sera with out the board of directors expressed written approval. There shall be no exceptions. Those instructors in the arts that I have created based on traditional sera shall be responsible to the board of Directors of Sera without exception or exemption. Those arts include but are not limited to Bukti Negara and Tenaga Nasip Sera.

You, Danny Huybrechts are neither the lineage holder of PDT Pukulan Pentjak Silat Sera nor the Lineage holder of PDT Pukulan Pentjak Silat Bukti Negara. This is my declaration.

Though you have served the art of Bukti Negara over these many years, you have forsaken the art and me by taking the side of one individual. In doing so, you have chosen an individual over me, the arts and most importantly the code of ethics which governs Sera and Bukti Negara. This saddens me very much to see that you have chosen an individual over all others. This is not what is expected of a good leader. You have failed the art and me.

You and all practitioners of PDT Pukulan Pentjak Silat Sera, PDT Pukulan Pentjak Silat Bukti Negara and or PDT Pukulan Pentjak Silat Tenaga Nasip Sera will be under the direct authority of the Board of Directors of Sera that I have appointed. This I declare without revocation.

Since you have directly defied my wishes as the creator of Bukti Negara, and declined to be the head of the board of PDT Pukulan Pentjak Silat Bukti Negara, I have chosen to pass the lineage of Bukti Negara to the Board of Directors of Sera. As stated above, you and all practitioners, teachers of any ranking regardless of time spent training with me or with the PDT Academy of Bukti Negara are now under the direct authority of the Board of Directors of Sera. All rights, privileges, names, trademarks and copyrights are assigned to the Board of Directors of Sera. The current trademarks and word marks of PDT Pukulan Pentjak Silat Bukti Negara and PDT Pukulan Pentjak Silat Sera shall be in the possession of the Board of

Directors of Sera. All right and privileges are therefore passed to the Board of Directors and its members.


Failure to adhere to the wishes of myself or the board of directors of Sera after my passing will result in immediate dismissal from Sera, Bukti Negara and or Tenaga Nasip Sera. All rights and privileges as an instructor and or practitioner shall be immediately revoked.

Any persons claiming authority in PDT Sera, or otherwise claiming ownership, instructorship, qualifications as a practitioner, teacher or any other means of making any type of association to myself or the arts of Sera as a means of promoting themselves and the art without the written consent of the board of sera shall be considered in violation of the rules and regulations of the art of sera. At which time legal action will be taken. The Board of Directors of Sera and myself have retained Lahooti and Associates Attorneys at Law as our legal council. Such a disgrace as to promote themselves without expressed written approval from the board of directors shall prove to all that he is not of strong moral character and is unworthy of the art.

The moral fabric of the traditional art of Pukulan Pentjak Silat Sera and or PDT Pukulan Pentjak Silat Bukti Negara is more than just Jurus, Sambuts, Lankas, etc. It is also based on my teachings of character and morality. Such violations to the art of sera, the board of directors and myself will not be tolerated at any time and for any reason.

The purpose of the board of directors is to maintain the integrity of the traditional art of Sera. Their responsibilities will include but are not limited to:

- Adat and hormat concerning Sera.
- Maintaining the integrity of the Jurus as taught by Paul De Thouars
- Maintaining the integrity of the Lankas as taught by Paul De Thouars
- Maintaining the integrity of the Sambuts as taught by Paul De Thouars
- Maintaining the integrity of the modified drills as taught by Paul De Thouars
- Overseeing the martial arts creations of Paul De Thouars which includes Bukti Negara and Tenaga Nasip Sera
- Upholding and perpetuating the moral and ethical teachings of Paul De Thouars regarding human behavior and interaction
