PETITION FOR CANCELLATION

GHSC Trading B.V., a Netherlands company doing business at Keienbergweg 51, 1101 GA Amsterdam Zuid-Oost, Netherlands (hereinafter "Petitioner"), believes it has and will continue to be damaged by the mark shown in Registration No. 4,526,180 for the GREENHOUSE mark registered May 06, 2014, by Kretek International, Inc., (hereinafter "Registrant"), and hereby petitions to cancel the registration. The grounds for cancellation are as follows:

1. On May 06, 2014, Registrant obtained Registration No. 4,526,180 for the **GREENHOUSE** mark on the Principal Register for "Tobacco jars; Tobacco tins" in International Class 34.
2. Petitioner markets and sells smokers' articles including oral vaporizers, electronic cigarettes, smoking papers, ash trays, rolling papers, and grinders. Petitioner also advocates for the public awareness of safe access to medical cannabis. All of these activities are provided in connection with Petitioner's well-known GREEN HOUSE and GREEN HOUSE SEED CO. marks.

3. Since at least as early as April 21, 2009, Petitioner has used the GREEN HOUSE mark in the United States in connection with smokers' articles. As such, Petitioner acquired common law trademark rights in the GREEN HOUSE mark. The GREEN HOUSE mark has been used to a sufficient nature to have acquired distinctiveness prior to the Registrant's filing date.

4. Petitioner owns and uses the trademark GREEN HOUSE SEED CO. in connection with prerecorded DVDs featuring information about cannabis in class 9, key chains and key rings of precious metal, watches, and jewelry in class 14, and cups, saucers, drinking glasses, plates, coffee stirrers and stirrers for other drinks, drip mats for tea, and bottle openers in class 21. These goods are related to the Registrant's described goods of tobacco jars and tobacco tins in International Class 34. Information about the GREEN HOUSE SEED CO. registration is shown in the table below:

6. Petitioner currently has pending the following trademark application on its GREEN HOUSE SEED CO. mark. Information about the GREEN HOUSE SEED CO. application is shown in the table below:

Registration from the USPTO's Trademark Status & Document Retrieval (TSDR) database are

attached as Exhibit A. As used hereinafter, "Petitioner's GREEN HOUSE Marks" shall include the GREEN HOUSE and GREEN HOUSE SEED CO. marks detailed above unless otherwise indicated.

7. Petitioner has advertised and promoted Petitioner's GREEN HOUSE Marks continuously and extensively and has made substantial sales of goods under the mark. As a result, Petitioner's GREEN HOUSE Marks developed and represent valuable goodwill inuring to the benefit of Petitioner.

8. There is no issue of priority since Petitioner used its GREEN HOUSE Marks long before Registrant's May 06, 2014 filing date and alleged January 01, 2014 first use date. Petitioner started using the GREEN HOUSE mark on smokers' articles as a trademark at least as early as 2009, five (5) years before Registrant allegedly began using the GREENHOUSE mark. Petitioner has priority over Registrant with respect to the marks at issue.

9. Registrant's GREENHOUSE mark is confusingly similar to Petitioner's GREEN HOUSE Marks in sight, sound, and commercial impression.

10. Registrant's goods are closely related to the goods and services marketed and sold by Petitioner under its GREEN HOUSE Mark. Both parties' marks are used in connection with smokers' articles. Petitioner's GREEN HOUSE common law rights cover, among other things, smokers' articles. Registrant has registered a confusingly similar GREENHOUSE mark for "Tobacco jars; Tobacco tins" in class 34.

11. Upon information and belief, Petitioner's goods and services and Registrant's goods are sold and marketed in the same channels of trade to the same consumers and/or class of consumers.

12. Upon information and belief, Registrant had knowledge of Petitioner's GREEN HOUSE Marks before it filed its GREENHOUSE application. By virtue of Petitioner's sales and promotion in the United States, which sales and promotion occurred prior to the filing date of Reg. No. 4,526,180, Registrant had knowledge of Petitioner's use of Petitioner's GREEN HOUSE Marks. Moreover, Petitioner used and promoted GREEN HOUSE in connection with smokers' articles since at least as early as 1994 in various countries outside of the United States, which is prior to the filing date of Reg. No. 4,526,180 and well before Registrant's alleged first use of the GREENHOUSE mark. Registrant had knowledge of Petitioner's use of the GREEN HOUSE mark in this foreign context.

13. The use and registration by Registrant of the GREENHOUSE mark for Registrant's goods and services is likely to cause confusion or to cause mistake or deception in the trade, and among purchasers and potential purchasers, with Petitioner's previously used GREEN HOUSE Mark, again resulting in damage to Petitioner.

14. Because of the nearly identical nature of the goods and services, and the similarity of the marks, use and registration of the term GREENHOUSE by Registrant is likely to cause confusion, mistake, or deception that Registrant's services are those of Petitioner, or are otherwise endorsed, sponsored, or approved by Petitioner causing further damage to Petitioner.

15. Registration of the mark shown in Registration No. 4,526,180 will result in damage to Petitioner under the provisions of Section 2 of the U.S. Trademark Act, 15 U.S.C. Section 1052.

WHEREFORE, Petitioner requests that its petition to cancel this registration be sustained and find that Registration No. 4,526,180 be cancelled.


