**PETITION FOR CANCELLATION  
PURSUANT TO 15 U.S.C. § 1064(a)**

In the matter of trademark Reg. No. 4300352 for the mark FERREIRA FOODS (“Registrant’s Mark”) for “sliced meat” in International Class 029 and “bakery goods, spices, tortilla chips, tortillas” in International Class 030 (“Registrant’s Goods”), which registration issued March 12, 2013, Petitioner, Sogrape Vinhos, S.A. (hereinafter, “Petitioner” or “Sogrape”), a *sociedade por ações* organized under the laws of Portugal and located and doing business at Lugar de Aldeia Nova, Avintes, Vila Nova de Gaia, P-4430-77, Portugal, believes that it will be damaged by the continued registration of Registrant’s Mark and hereby petitions to cancel said registration pursuant to 15 U.S.C. §1064 (Trademark Act of 1946, §14).

As grounds for cancellation, Sogrape alleges the following:

1. Sogrape is the owner of the marks FERREIRA, FERREIRA PORTO, and CASA FERREIRINHA (“Petitioner’s Marks”)(as also identified and depicted hereinbelow in Paragraphs 5 and 6) as trademarks applied to wines (“Petitioner’s Goods”), the same being directed to wholesale and retail customers.

2. Sogrape is now and for many years has been trading as and known by Petitioner's Marks, the same identifying Petitioner as the source of Petitioner's Goods.

3. Sogrape is now and for many years prior to any date which may be claimed by Registrant, engaged in the use of Petitioner's Marks on and in association with Petitioner's Goods and is the owner of the registrations and pending applications therefor, including *inter alia* those identified in Paragraphs 5 and 6 below.

4. Since long prior to any date which may be claimed by Registrant, Sogrape has been and is now engaged in the use of Petitioner's Marks on and in association with Petitioner's Goods in interstate commerce.

5. Sogrape is the owner of, *inter alia*, the following U.S. trademark registrations which are in good order and in the name of and owned by Petitioner:

6. Petitioner also is the owner of the common law trademark CASA FERREIRINHA in use in U.S. commerce on wines.

7. Petitioner's Marks have been in continuous, open, and notorious use in the United States from 1968 to the present date.

8. Petitioner's Marks have been continuously and widely advertised and promoted in the United States from 1968 to the present date.

9. As a result of long use, widespread advertising and promotion, and successful sales, advertising and promotion for over forty-five (45) years, Petitioner's Marks have become distinctive and well-known and highly regarded throughout the United States, long prior to the date Registrant filed the application in issue and long prior to any date of use that may be claimed by Registrant.

10. As a result of the expenditure by Petitioner of substantial sums in establishing, maintaining, and policing Petitioner's Marks as symbols of Petitioner and its quality products, the trade and purchasing public have come to recognize Petitioner's Marks as identifying Petitioner's quality products and as indicating Petitioner as the sole source of those products.

11. Notwithstanding Sogrape's prior rights in Petitioner's Marks, Registrant applied to register FERREIRA FOODS for Registrant's Goods in International Classes 029 and 030 on March 22, 2012.

12. The application identified hereinabove in Paragraph 11 was registered on March 12, 2013 under Registration No. 4,300,352 (hereinafter, the "352 Registration"). Sogrape seeks cancellation of the '352 Registration in its entirety.

13. For far longer than any date than could be claimed by Registrant, Sogrape has been trading and is known by Petitioner's Marks in connection with the marketing and sale of Petitioner's Goods, the same being generally related to Registrant's Goods. As such, priority is not an issue.

14. Upon information and belief, Registrant intends to distribute and sell Registrant's Goods through the same channels of trade as Petitioner, and directs its respective goods to the same ultimate consumer as Petitioner.

15. Registrant's Goods are of the sort that are typically: (i) consumed in tandem with or mixed in recipes with the goods sold by Petitioner under Petitioner's Marks; and (ii) sold by restaurants, caterers or other retail food establishments such as that which Petitioner provides under Petitioner's Marks.

16. The Petitioner's Marks and Registrant's Mark are confusingly similar when applied to the goods of the parties and Registrant's use of Registrant's Mark in connection with Registrant's Goods is without the consent or permission of Petitioner.

**I. LIKELIHOOD OF CONFUSION/ FALSE SUGGESTION OF A CONNECTION**

17. The Petitioner's Marks and Registrant's Mark are confusingly similar when applied to the goods of the parties.

18. Since Petitioner owns Petitioner's Marks by virtue of prior use, mistake or deception as to the source of origin of the goods will arise and will injure and damage Sogrape and its goodwill.

19. The continued registration of the Registrant's Mark to Registrant will cause the relevant purchasing public to erroneously assume and thus be confused, misled, or deceived, that Registrant's Goods are made by, licensed by, controlled by, sponsored by, or in some way connected, related or associated with Petitioner, all to Petitioner's irreparable damage.

**II. FRAUD ON THE USPTO**

20. Sogrape repeats and re-alleges paragraphs 1-19 above with the same force and effect as if set forth herein at length.

21. In filing the application that led to Registrant's Mark on March 22, 2012 in International Class 029 for "sliced meat," Registrant used a specimen for a solid, processed meat product, namely:



22. The specimen demonstrating use of Registrant's Mark in International Class 029 is not a "sliced meat" product.

23. At no time prior to the filing of the application was Registrant's Mark in International Class 029 in use in U.S. commerce on "sliced meat."

24. In connection with the Class 029 portion of its application, Registrant knowingly made false material representations of fact in connection with the filing of its application.

25. The USPTO relied upon the misrepresentations made by Applicant when it published and subsequently registered Registrant's Mark in International Class 029.

26. The false and fraudulent declarations referred to above with respect to Registrant's Mark in International Class 029 was made by Registrant with actual knowledge of its falsity, and was not made on information and belief and was made by a person who knew or should have known the same was false and fraudulent.

27. As a result, Registrant willfully and knowingly perpetuated a fraud on the USPTO in connection with the Class 029 portion of its application.
