PETITION FOR CANCELLATION

Supreme Brands, L.L.C., a Minnesota limited liability company with a principal place of business at 100 South 5th Street - #1075, Minneapolis, Minnesota ("Petitioner"), believes that it will be damaged by the continued registration of U.S. Registration No. 2,141,162 of the mark CHRISTIAN and hereby petitions to cancel the same. As grounds for cancellation, it is alleged that:

1. The record Registrant, BOA Athletics, LLC (hereinafter "Registrant"), is a Colorado limited liability company with a last-known address of 4885 Fenwood Drive, Highlands Ranch, Colorado 80130.
2. Registrant filed an application to register the mark CHRISTIAN in the United States Patent and Trademark Office on December 9, 1997. This application was accorded Serial Number 75/306,054.

3. Registrant's application Serial Number 75/306,054 issued into Registration No. 2,141,162 on March 3, 1998 for "ice hockey and in-line hockey equipment, namely, sticks, replacement blades, hockey stick shafts, blade removal tools for use with ice hockey and in-line hockey sticks, and ice hockey and in-line hockey protective equipment, namely, hockey gloves, elbow pads, shoulder pads, shin guards, hockey pants, hockey girdles, and hockey shorts" in International Class 028.

4. Petitioner is the owner of pending U.S. Trademark Application Serial No. 86/597,167 for the mark CHRISTIAN for "ice hockey sticks" in International Class 028.

5. The Examining Attorney has cited U.S. Registration No. 2,141,162 as a bar to registration of Petitioner's application, Serial No. 86/597,167. As such, Petitioner has standing to bring this action.

6. Upon information and belief, Registrant is not using its mark CHRISTIAN that is the subject of U.S. Registration No. 2,141,162 in commerce in connection with "ice hockey and in-line hockey equipment, namely, sticks, replacement blades, hockey stick shafts, blade removal tools for use with ice hockey and in-line hockey sticks, and ice hockey and in-line hockey protective equipment, namely, hockey gloves, elbow pads, shoulder pads, shin guards, hockey pants, hockey girdles, and hockey shorts" in International Class 028.

7. Upon information and belief, Registrant has abandoned its mark CHRISTIAN that is the subject of U.S. Registration No. 2,141,162 through non-use in

connection with “ice hockey and in-line hockey equipment, namely, sticks, replacement blades, hockey stick shafts, blade removal tools for use with ice hockey and in-line hockey sticks, and ice hockey and in-line hockey protective equipment, namely, hockey gloves, elbow pads, shoulder pads, shin guards, hockey pants, hockey girdles, and hockey shorts” in International Class 028 without intent to resume use of the CHRISTIAN mark in commerce.

WHEREFORE, Petitioner requests that U.S. Reg. No. 2,141,162 of the mark CHRISTIAN in connection with “ice hockey and in-line hockey equipment, namely, sticks, replacement blades, hockey stick shafts, blade removal tools for use with ice hockey and in-line hockey sticks, and ice hockey and in-line hockey protective equipment, namely, hockey gloves, elbow pads, shoulder pads, shin guards, hockey pants, hockey girdles, and hockey shorts” in International Class 028 be cancelled, and that this Petition for Cancellation be sustained in Petitioner’s favor.

Lance Lieberman declares that he is an attorney for Petitioner Supreme Brands, L.L.C. and is authorized to execute this Petition for Cancellation and Declaration on Petitioner’s behalf; that he has read the foregoing Petition for Cancellation and knows the contents thereof; that the facts and allegations set forth therein are, to the best of his knowledge, true and correct except as to matters stated therein to be upon information and belief and that as to those matters he believes them to be true; and, further, that these statements were made with the knowledge that willful false statements and the like so made

are punishable by fine, or imprisonment, or both under Section 1001 of Title 18 of the United States Code, and that such willful false statements may jeopardize the validity of the Cancellation.


