PETITION TO CANCEL

Hope Network, Inc. ("Petitioner") hereby petitions to cancel U.S. Trademark Registration Nos. 4129677 (MEN TALK ABOUT IT) and 4455772 (VETERANS TALK ABOUT IT) on the following grounds:

1. Hope Network, Inc. is a Michigan corporation having a place of business at 3075 Orchard Vista Dr. SE, Grand Rapids, MI, 49546.
2. According to the records of the United States Patent and Trademark Office, the current owner of U.S. Trademark Registration No. 4129677 is Charles W. Solomonson, having an address of 508 Sandy Court, Libertyville, IL 60048.
3. According to the records of the United States Patent and Trademark Office, the current owner of U.S. Trademark Registration No. 4455772 is Charles W. Solomonson, DBA, Men Talk About It, LLC, a limited liability company formed under the laws of the State of Illinois, and having a correspondence address of 137 Center, Suite A, Grayslake, IL 60030.

4. Petitioner is the owner of U.S. Trademark Application Serial No. 87069481 for the trademark TALK ABOUT IT, filed on June 13, 2016 and alleges a bona fide intention to use the mark in commerce under Section 1(b) of the Lanham Act.

5. Petitioner is the owner of U.S. Trademark Application Serial No. 87069465 for the trademark TALK ABOUT IT, filed on June 13, 2016 and alleges a bona fide intention to use the mark in commerce under Section 1(b) of the Lanham Act.

6. On information and belief, Registrant has ceased use of each of the MEN TALK ABOUT IT and VETERANS TALK ABOUT IT marks in connection with the services identified in U.S. Trademark Registrations 4129677 and 4455772, and intends not to resume such use.

7. On information and belief, the company Men Talk About It, LLC was voluntarily dissolved on March 31, 2015. See Ex. A.

8. On information and belief, there is no use of the mark MEN TALK ABOUT IT related to the services recited in U.S. Trademark Registration 4129677.

9. On information and belief, there is no use of the mark VETERANS TALK ABOUT IT related to the services recited in U.S. Trademark Registration 4455772.

10. As a result of the non-use of the each of the marks MEN TALK ABOUT IT and VETERANS TALK ABOUT IT in connection with the services identified in U.S. Trademark Registrations 4129677 and 4455772 with an intention not to resume use, Registrant has abandoned the aforementioned marks with respect to those services within the meaning of 15 U.S.C. § 1127.

WHEREFORE, Petitioner prays that the Trademark Trial and Appeal Board grant it petition and cancel U.S. Trademark Registration Nos. 4129677 and 4455772.
