3. On June 30, 2015, Petitioner filed with the United States Patent and Trademark Office (“USPTO”) an U.S. Extension of Protection for the mark SKYPANEL, Ser. No. 79177608, for goods in Classes 9 and 11 which are intended to be used for use in connection with motion picture and broadcast equipment (“Petitioner’s Application”).

4. The USPTO has refused Petitioner’s Application under Section 2(d) of the Trademark Act based on the cited registration of the alleged mark SKYPANEL, Reg. No. 4633574, for “LED displays”, in the name of ADTI Media, LLC (“Cited Registration”), located at 42230 Zevo Drive, Temecula, California 92590.

5. Petitioner hereby requests that the Board, pursuant to Section 18 of the Trademark Act, partially cancel or restrict the goods set forth in the Cited Registration to the following, which upon information and belief, are the actual goods Registrant uses in commerce its alleged mark SKYPANEL on:

*Outdoor LED displays used in advertising and not for use in applications in the motion picture and broadcast industry*

6. The requested restriction or modification of the Cited Registration would avoid a continued finding by the USPTO that there is a likelihood of confusion between the Petitioner’s mark SKYPANEL, which is the subject of Petitioner’s Application, on the one hand, and Registrant’s alleged mark SKYPANEL, which is the subject of the Cited Registration, on the other.


**WHEREFORE**, it is respectfully requested that the Board partially cancel or restrict the Cited Registration as set forth herein.


