

Pursuant to T.B.M.P. § 309.03(c), Petitioner, Globe International Nominees Pty Ltd., (“Globe”) believes that it has been and will continue to be damaged by U.S. Trademark Registration No. 4971328 (“Respondent’s Registration”) for the mark GLOBE RUNNER and Design (RUNNER disclaimed) and hereby petitions to cancel the same.

A description of Respondent’s Registration is as follows:

As grounds for this Petition, it is alleged that:

1. Upon information and belief, Globe Runner LLC, a limited liability company organized under the laws of Tennessee, having an address of 409 Autumn Lake Trail, Franklin, Tennessee 37067 (“Respondent”), is the owner of Respondent’s Registration.

2. On or about April 28, 2014, Respondent filed an application for the mark



with the U.S. Patent and Trademark Office (“PTO”) and it was assigned Serial No. 86/264,352 (“Respondent’s Application”). Respondent’s Application claimed a date of first use of September 20, 2013 and a date of first use in commerce of February 1, 2014.

3. On or about June 7, 2016, Respondent’s Application matured to registration and was assigned Registration No. 4,971,328.

8. Since at least as early as 1996, a date well before the filing of Respondent’s Application and well before the alleged date of first use anywhere and first use in commerce alleged in Respondent’s Registration, Globe International Nominees Pty Ltd, its predecessors-in-interest and its affiliates (collectively “Globe”) have marketed, promoted, offered for sale, provided and sold various goods and services in connection with the name and mark GLOBE in

U.S. commerce. Among the goods provided by Globe are sporting goods, recreation equipment, toys, bobbleheads, furniture, clothing, headwear, footwear, skatewear, skate accessories, bags, wallets, jewelry, consumer electronic products, key chains, stickers, towels, printed materials, videos, DVDs and other general merchandise and related goods and accessories (collectively, “Globe’s Goods”) in connection with various marks containing the term GLOBE (collectively, the “GLOBE Marks”).

5. Globe also uses the GLOBE Marks in connection with various services, including, but not limited to, on-line retail store services featuring Globe’s Goods, sports competitions, including skateboarding competitions, sports demonstrations, including, but not limited to, skateboarding demonstrations, sports exhibitions, including, but not limited to skateboarding exhibitions, sponsorship of sports teams, including, but not limited to sporting events, education and training, charitable and fundraising events, and the provision of information regarding the foregoing services (collectively “Globe’s Services”). Furthermore, Globe advertises and promotes Globe’s Goods and Globe’s Services in various print and electronic media.

6. Globe also uses the GLOBE name and GLOBE Marks on the Internet, including, but not limited to, on its website located at <https://www.globebrand.com/>.

9. Through advertising, promotion, and sale of Globe’s Goods and Globe’s Services in U.S. commerce under the mark GLOBE, since a date long prior to the filing date of Respondent’s Application and prior to the date of first use and first use in commerce alleged in Respondent’s Registration, Respondent has built up valuable goodwill symbolized by the GLOBE Marks.

10. Globe is the owner of and relies on U.S. Trademark Registration No. 1,991,488 (the “488 Registration”) for the mark GLOBE in connection with clothing, namely, tops, shirts, pants, shorts, sweaters and jackets in International Class 25, which was registered on the Principal Register on August 6, 1996. The ’488 Registration is based on an application filed in

the U.S. Patent and Trademark Office (“PTO”) on January 8, 1993 and claims a date of first use of February 5, 1996. Thus, the dates of first use, application and registration of the mark shown in the ’488 Registration are all prior to filing date of Respondent’s Application and prior to the date of first use and first use in commerce alleged in Respondent’s Registration. By virtue of Globe’s compliance with the provisions of 15 U.S.C. § 1065, Globe’s right to use the GLOBE mark shown in the ’488 Registration is incontestable. True and correct copies of the specifics of the ’488 Registration obtained from the PTO’s Trademark Status and Document Retrieval (“TSDR”) database is attached hereto as part of Exhibit 1 and made of record.

11. Globe is the owner and relies on U.S. Trademark Registration No. 2,601,308 (the “’308 Registration”) for the mark GLOBE AUSTRALIA and Design in connection with footwear in International Class 25, which was registered on the Principal Register on July 30, 2002. The ’308 Registration is based on an application filed in the PTO on March 12, 1996 and claims a date of first use of June 1996. Thus, the dates of first use, application and registration shown in the ’308 Registration are all prior to the filing date of Respondent’s Application and prior to the date of first use and first use in commerce alleged in Respondent’s Registration. . True and correct copies of the specifics of the ’308 Registration obtained from the PTO’s TSDR, database is attached hereto as part of Exhibit 1 and made of record.

12. Globe is the owner and relies on U.S. Trademark Registration No. 2,801,746 (the “’746 Registration”) for the mark GLOBE in connection with clothing, namely, t-shirts, socks, jeans, sweatshirts, pullovers, headwear and footwear in International Class 25 and bags, namely, all purpose athletic bags, backpacks, book bags, gym bags, school bags, and travel bags in International Class 18, which was registered on the Principal Register on January 6, 2004. The ’746 Registration is based on an application filed in the PTO on July 18, 2001 and claims a date of first use of May 1995 for the goods in International Class 25 and October 1996 for the goods in International Class 18. Thus, the dates of first use, application and registration shown in the

'746 Registrations are all prior to the date Respondent filed Respondent's Application and prior to the date of first use and first use in commerce alleged in Respondent's Registration. By virtue of Globe's compliance with the provisions of 15 U.S.C. § 1065, Globe's right to use the GLOBE mark shown in the '746 Registration is incontestable. True and correct copies of the specifics of the '746 Registration obtained from the PTO's TSDR database is attached hereto as part of Exhibit 1 and made of record.

13. Globe is the owner and relies on U.S. Trademark Registration No. 3,500,812 (the "'812 Registration") for the mark GLOBE in connection with skateboards, skateboard wheels sold both separately and as a unit, hardware and parts therefor, namely, bearings, mounting hardware, trucks, decks, grip tape, in International Class 28, which was registered on the Principal Register on September 16, 2008. The '812 Registration is based on an application filed in the PTO on July 18, 2007. Thus, the dates of application and registration shown in the '812 Registration are both prior to the date Respondent filed Respondent's Application and prior to the date of first use and first use in commerce alleged in Respondent's Registration. True and correct copies of the specifics of the '812 Registration obtained from the PTO's TSDR database is attached hereto as part of Exhibit 1 and made of record.

14. Globe is the owner and relies on U.S. Trademark Registration No. 3,744,809 (the "'809 Registration") for the mark GLOBE in connection with on-line retail store services featuring clothing, headwear, footwear, bags, sporting goods, recreation equipment, toys, DVDs, consumer electronic products and general merchandise in International Class 35, which was registered on the Principal Register on February 2, 2010. The '809 Registration is based on an application filed in the PTO on April 23, 2008. Thus, the dates of first use, application and registration shown in the '809 Registration are all prior to the date Respondent filed Respondent's Application, prior to the dates of first use and first use in commerce alleged in Respondent's Registration and prior to the issuance of Respondent's Registration. True and

correct copies of the specifics of the '809 Registration obtained from the PTO's TSDR database is attached hereto as part of Exhibit 1 and made of record.

15. Globe is the owner and relies on U.S. Trademark Registration No. 4,110,786 (the "'786 Registration") for the mark GLOBE UNITED BY FATE in connection with Watches; wristwatches; watch bands; watch straps; clocks; horological and chronometric instruments in International Class 14, which was registered on the Principal Register on March 13, 2012. The '786 Registration is based on an application filed in the PTO on June 11, 2011. Thus, the dates of application and registration shown in the '786 Registration are both prior to the date Respondent filed Respondent's Application, prior to the date of first use and first use in commerce alleged in Respondent's Registration and prior to the issuance of Respondent's Registration. True and correct copies of the specifics of the '786 Registration obtained from the PTO's TSDR databases is attached hereto as part of Exhibit 1 and made of record.

16. Globe is the owner of and relies upon its United States Registrations as specified above (collectively "Globe's Registrations"). Globe's Registrations are valid, subsisting, unrevoked and uncancelled; as such they constitute prima facie evidence of the validity of the registered marks and of the registrations thereof, and of Globe's ownership of the marks shown therein and of Globe's exclusive right to use the marks in commerce in connection with the goods named therein, without condition or limitation. Globe's Registrations also constitute notice to Respondent of Globe's claim of ownership of the marks shown therein; all as provided in Section 7(b), 22 and 33(a) of the Trademark Act of 1946, as amended.

17. Globe's Registrations are derived from applications filed in the PTO on dates

prior to the filing of Respondent's Application for the mark



and prior the dates of

first use and first use in commerce alleged in Respondent's Registration. Globe's Registrations are valid and subsisting.

18. In view of the substantial similarity of the parties' respective marks and the related nature of the goods and services of the respective parties, it is alleged that the mark in Respondent's Registration so resembles the marks in Globe's Registrations, previously used in the United States and not abandoned, as to be likely to cause confusion or to cause mistake or deceive.

19. Globe's use of the GLOBE Marks has been valid and continuous since at least as early as the dates of first use specified above and has not been abandoned. The GLOBE Marks are symbolic of extensive goodwill and consumer recognition built by Globe through substantial amounts of time and effort in advertising and promotion. In view of the similarity of the GLOBE Marks and the mark in Respondent's Registration and the related goods and services of the respective marks, the mark in Respondent's Registration so resembles one or more of the GLOBE Marks previously used in the United States and not abandoned so as to be likely to cause confusion or to cause mistake or to deceive.

20. Since at least as early as the dates of first use alleged above, Globe has consistently used the GLOBE Marks in interstate commerce in connection with Globe's Goods and Globe's Services. The GLOBE Marks by virtue of their substantial use, have acquired great value as an identification of Globe's Goods and Globe's Services, and distinguish them from the goods and services of others.

21. Since at least as early as the dates of first use stated above, Globe has used the GLOBE Marks in connection with the sale and promotion of Globe's Goods and Globe's Services. Such use has been valid and continuous, and has not been abandoned. Based on Globe's prior use of the GLOBE Marks in U.S. commerce since a date prior to the date of first

use and first use in commerce alleged in Respondent's Application and Respondent Registration, Globe has priority and prior rights over the mark in Respondent's Registration.

22. Globe has invested substantial amounts of time, effort and money in the GLOBE Marks throughout the United States and the world. By reason of Globe's widespread and continuous use of the GLOBE Marks, in addition to the protection afforded the to Globe's Registrations, Globe has extensive, non-registered statutory and common law rights in the GLOBE Marks. These common law rights are prior and senior to the filing date of Respondent's Application and prior and senior to the dates of first use and first use in commerce alleged in Respondent's Registration.

23. Globe, through sales, advertising and promotion of Globe's Goods and Globe's Services under the GLOBE Marks, Globe has built up at great expense and effort, valuable goodwill and consumer recognition. In view of the substantial similarity of the respective marks and the related nature of the goods and services of the respective parties, it is alleged that the mark in Respondent's Registration so resembles the GLOBE Marks previously used in the United States, and not abandoned, as to be likely to cause confusion, or to cause mistake or deceive.

24. The mark in Respondent's Registration is confusingly similar to the marks in Globe's Registrations. Additionally, Respondent's Registration is for goods identical or related to the goods identified in Globe's Registrations. As such, when the mark in Respondent's Registration is used on or in connection with Respondent's goods, it is likely to cause confusion, or to cause mistake or to deceive within the meaning of Section 2(d) of the Trademark Act, 15 U.S.C. § 1052(d).

25. The mark in Respondent's Registration is confusingly similar to the GLOBE Marks. Additionally, Respondent's Registration is for goods related to or identical to one or more of Globe's Goods. As such, when the mark in Respondent's Registration is used on or in

connection with the goods identified therein, it is likely to cause confusion, or to cause mistake or to deceive within the meaning of Section 2(d) of the Trademark Act, 15 U.S.C. § 1052(d).

26. The mark in Respondent's Registration is confusingly similar to the marks in Globe's Registrations. Additionally, the goods in Respondent's Registration are related to the goods in Globe's Registrations. Accordingly, The mark in Respondent's Registration, and use thereof, is likely to cause confusion in, or to cause mistake by, or to deceive the trade and purchasing public into believing that goods provided by Respondent originate with Globe or are otherwise authorized, endorsed by, licensed by or sponsored by Globe.

27. The mark in Respondent's Registration is confusingly similar to the marks in Globe's Registrations. Additionally, the goods in Respondent's Registration are identical to some of the goods in Globe's Registrations. Accordingly, the mark in Respondent's Registration, and use thereof, is likely to cause confusion in, or to cause mistake by, or to deceive the trade and purchasing public into believing that goods provided by Respondent originate with Globe or are otherwise authorized, endorsed by, licensed by or sponsored by Globe.

28. The mark in Respondent's Registration is confusingly similar to the GLOBE Marks. Additionally, Respondent's Registration for goods related to Globe's Goods and Globe's Services. Accordingly, the mark in Respondent's Registration and use thereof, is likely to cause confusion in, or to cause mistake by, or to deceive the trade and purchasing public into believing that Respondent's goods originate with Globe or are otherwise authorized, endorsed by, licensed by or sponsored by Globe.

29. In view of Globe's prior rights in the GLOBE Marks, Respondent is not entitled to maintain Respondent's Registration pursuant to Section 2(d) of the Lanham Act, 15 U.S.C. § 1052(d).

30. Respondent has no license, consent or permission from Globe to use or register the mark in Respondent's Registration.

32. Respondent has no license, consent or permission from Globe to use or register the mark GLOBE.

33. The dominant portion of the mark in Respondent's Registration is GLOBE.

34. The term RUNNER is disclaimed in Respondent's Registration.

35. The only literal portion of the mark in Respondent's Registration that is not disclaimed is GLOBE.

36. The mark in the '488 Registration is GLOBE.

37. The dominant portion of the mark in the '308 Registration is GLOBE.

38. The mark in the '746 Registration is GLOBE.

39. The mark in the '812 Registration is GLOBE.

40. The mark in the '809 Registration is GLOBE.

41. The first term of the mark in the '308 Registration is GLOBE.

42. If Respondent is permitted to maintain its registration for the mark in Respondent's Registration, Respondent's corresponding prima facie exclusive right to use the mark in nationwide commerce will conflict with Globe's lawful and prima facie exclusive right to use the GLOBE Marks nationwide.

43. As Globe is the prior and senior user of the mark GLOBE, Globe is and will continue to be damaged by the continued registration of Respondent's Registration.

44. By virtue of the foregoing, Globe will be damaged by the continued registration of the Respondent's Registration.

45. By virtue of the foregoing, Globe is currently gravely damaged by the registration of the Respondent's Registration because continued registration of this mark violates Globe's trademark, service mark, and/or trade name rights.

46. In view of Globe's Registrations, Respondent is not entitled to registration of the mark pursuant to Section 14(3) of the Trademark Act, 15 U.S.C. § 1064(3), and as such, said registration should be cancelled.




