Pursuant to our prior telephone conversations, my client would again request the Declaration of Incontestability, pursuant to Section 15, be granted. On April 14, 2003, the Section 15 Affidavit was received by the U.S.P.T.O. The Section 15 Affidavit was delayed due to a Concurrent Use Proceeding No. [redacted]. On January 25, 2005, the Concurrent Use Proceeding was resolved and concurrent use was granted.
