JOINT MOTION TO EXTEND

The parties, through their undersigned counsel, jointly file this motion to extend the time to respond to the TTAB's order dated December 13, 2008 (the "Order") in the proceeding referred to above. The Order requires that the parties submit an amendment to their Settlement Agreement stating each party's territory of use with the requisite specificity, and further requires that they file a stipulation of dismissal of this concurrent use proceeding with respect to Registration No. 2992750, which is owned by Ohio Farmers Insurance Company. The Order allowed thirty days from the mailing date (i.e., until January 12, 2009) for the parties to respond. In a subsequent order dated January 27, 2009, the TTAB granted the parties' joint motion for additional time until February 11, 2009 to respond to the Order.

The parties have been actively discussing the issues raised by the Order and anticipate being able to file their substantive response in the near future. However, the parties have also been discussing the possibility of making further amendments to their Settlement Agreement and have not been able to conclude those discussions during the extended response period. Accordingly, the parties jointly request that the TTAB extend the deadline to respond to the Order by fifteen (15) days to and including February 26, 2009.
