
This request for extension is not being made for the purpose of delay of the proceedings,



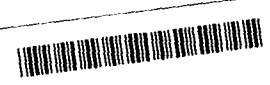
