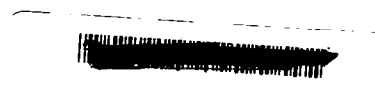

Sir:




