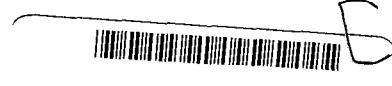


for filing a Notice of Opposition to the registration of the above mark be extended for an additional sixty-day period from September 12, 2002 to and including November 11, 2002.


