
RESPONSE TO SHOW CAUSE ORDER

Wherefore, Applicant respectfully requests that the Board grant its extension request filed on June 18, 2003 and accept its Appeal Brief as timely filed.



On June 3, 2003, the Board issued an Order allowing Applicant until June 19, 2003 to file its Appeal Brief.
