**REQUEST (WITH CONSENT) FOR EXTENSION OF TIME
TO FILE NOTICE OF OPPOSITION**

In the matter of Trademark Application Serial No. 76/046,949, owned by Piratetoons.com, Inc., filed on May 11, 2000, toward registration of the mark "PIRATENET" for:

Series of prerecorded video and audio cassettes, tapes and compact discs all featuring animation, live action and musical performances; decorative magnets; photographic equipment, accessories and materials, namely cameras; cinematographic apparatus and instruments, namely, cameras and slide, video and digital image projectors; recording apparatus and instrument, namely tape recorders, digital audio tape recorders, electrical apparatus and instruments, namely, compact disc players and recorders, DVD players and recorders, tape and audio cassette players and recorders, televisions, video monitors, computer monitors, video recorders and players, radios, audio speakers, headphones, stereo tuners, stereo receivers, stereo amplifiers, graphic equalizers, telephones, answering machines, computer programs for use in creating and manipulating animated characters and animated content; computer game programs featuring animated characters; motion picture films, DVD's and digital recordings, all featuring animation and live action; phonograph records, pre-recorded audio tapes and digital audio tapes featuring popular and children's music; computer game equipment containing memory devices namely discs; and video game machines for use with televisions in International Class 9;

Art paper, loose leaf paper, note paper, writing paper; printed matter, namely books, magazines, newsletters, and brochures all featuring animation or pirates; gift wrapping paper, stationery, packing paper, bumper stickers, songbooks, mounted and unmounted photographs, calendars in International Class 16;

Shirts, T-shirts, sweatshirts, robes, sweaters, coats, caps, hats, visors, tops, jackets, jeans, pants, sweat pants, boots, shoes and slippers in International Class 25;

Toys, games, playthings, and sporting articles, namely targets games, kites, toy action figures, board games and card games, disc-type toss toys, toy bows and arrows, archery equipment namely bows and arrows; basketballs, baseballs, volleyballs, dolls, doll playsets, plush toys, toy vehicles, toy cars, toy trucks, toy bucket and shovel sets, roller skates, toy model hobbycraft kits, toy rockets, toy guns, toy holsters, musical toys, jigsaw puzzles, badminton sets, bubble making wands and solution sets, toy figurines, toy banks, puppets, toy balloons, yo-yos, skateboards, scooters, face masks, stand alone video game machines, and hand-held units for playing electronic games; Christmas tree ornaments and Christmas tree decorations except confectionery and illumination articles in International Class 28; and

Providing a web-site featuring entertainment services in the nature of animated cartoons and information about animated cartoons and television programming via a global computer network; animation production services; special effects animation services for film and video in International Class 41

published for Opposition on March 5, 2002 in the *Official Gazette* at pages TM 101-102.

Potential Opposer, Cine Craft Limited, a company organized and existing under the laws of Gibraltar of the United Kingdom, having an address at Suite 2, Horse Barrack Court, 9/15 Horse Barrack Lane, Gibraltar, United Kingdom, requests that the time for filing a Notice of Opposition to the above application be further extended to and including January 29, 2003.

The parties appear to have reached an agreement in principle for an amicable resolution. A Settlement Agreement has been finalized for execution with respect to this Application as well as another later published Application. However, additional time is required in order to have the Settlement Agreement executed, particularly in view of the Potential Opposer being in Spain.

Counsel for Applicant, Steve Plotkin, consented to a sixty (60) day extension in a telephone conference with the undersigned on November 22, 2002.

The foregoing request is not being filed for the purpose of mere delay of proceedings, and favorable consideration of this request is respectfully solicited.
