The parties are currently involved in settlement negotiations to resolve their present dispute regarding the above-identified mark and believe that the matter will be settled prior to the





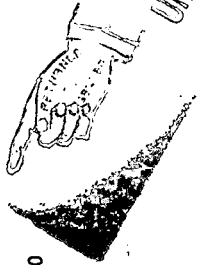
