


REQUEST FOR FURTHER EXTENSION OF TIME TO OPPOSE

Rainbow Technologies, Inc., the Potential Opposer in the above-identified matter, seeks a further thirty (30) day extension of time to oppose Application Serial No. 76/145024. Applicant's counsel expressly consented to this additional extension in a phone call with the undersigned on January 16, 2003, since a settlement agreement between the parties has been drafted, and is simply awaiting final approval by the parties. Further, Applicant's counsel informed the undersigned that her client's mother recently passed away, and therefore her client has been unable to give the draft settlement agreement his immediate attention. The foregoing is good cause why this request for a further extension of the opposition deadline should be granted.

The original deadline for opposing the above-identified application was August 21, 2003. A thirty (30) day extension was applied for by, and granted to Potential Opposer, extending the deadline to September 20, 2003. Then, a further ninety (90) day extension of the opposition deadline is requested, up to and including December 19, 2003. Later an additional thirty (30) day extension was granted extending the deadline to January 18, 2004. It should be noted that the first extension request filed in this opposition was filed prior to November 2, 2003, the date the Madrid Protocol became effective, and therefore is not governed by the new rules pertaining to extension requests


