REQUEST FOR EXTENSION OF TIME TO FILE NOTICE OF OPPOSITION



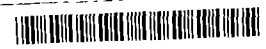
