Request for Extension of Time to File Notice of Opposition (Stipulated)

The Chancellors and Masters of the University of Oxford (the "University of Oxford"), an entity incorporated by royal charter in 1357, and subsequently by the Oxford & Cambridge Act of 1571 in the United Kingdom having its principal place of business at Great Clarendon Street, Oxford OX2 6DP United Kingdom, by and through its attorneys, Satterlee Stephens Burke & Burke LLP, hereby requests that the Board grant an additional thirty (30) day extension of time to file a Notice of Opposition in the above-identified matter. The Applicant, Fame Information Services, Inc., ("Fame") agreed to this extension by e-mail, dated March 15, 2004.


