AND TO HIS ATTORNEY OF RECORD:


PLEASE TAKE NOTICE THAT the Opponent, David Dew, believes that he would be

2 papers.

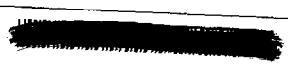
