**FIFTH STIPULATED REQUEST FOR EXTENSION OF TIME  
UNDER RULE 2.102 TO FILE NOTICE OF OPPOSITION**

UnumProvident Corporation, a Delaware Corporation, hereby requests an additional extension of time of sixty days to file a Notice of Opposition against the above-identified application, to and including September 24, 2003.

The extension is required to provide time for counsel for potential Opposer and counsel for Applicant to continue to work toward settlement of this matter. Specifically, Opposer has provided Applicant's counsel with a draft settlement agreement on February 10, 2003. Before accepting the agreement, Applicant requested further information from Opposer regarding its Lighthouse design. Opposer provided this information to Applicant on April 2, 2003. Applicant's counsel has now requested clarification of some of the information provided by Opposer. Genis, counsel for Applicant, consented to this extension on July 14, 2003. Because of the travel schedules of Applicant's and Opposer's counsel, the parties believe that it may take an additional sixty days to complete work toward settlement.


