This request is not made for the purpose of unduly delaying proceedings in the Patent and Trademark Office.





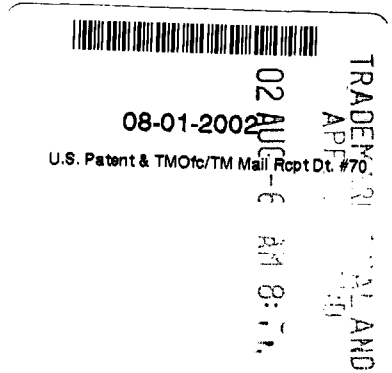
