Miller Brewing Company, a Wisconsin corporation with its principal place of business at 3939 West Highland Boulevard, Milwaukee, Wisconsin 53208, hereby requests that its time for filing a notice of opposition to the above-entitled trademark application be extended by an additional sixty days, to February 24, 2004. Miller Brewing Company has previously been granted an extension of time to file a notice of opposition, to December 26, 2003.

Miller Brewing Company respectfully submits that good cause exists for the further extension of time. proposal made by the applicant. No agreement has yet been reached, but it is believed that additional time will allow the parties to have further discussions and perhaps to reach an agreement.
