
This extension of time is requested in order to afford a sufficient opportunity for Petitioner to complete an investigation as to the implications of the publication of the above-

This Request for Extension of Time to File a Notice of Opposition is being submitted in triplicate, pursuant to 37 C.F.R. § 2.102(d).


