An initial request to extend the deadline to August 2, 2003 has been granted by the Board. This request would extend the deadline to October 1, 2003.


Potential Opposers request this time to complete their evaluation of the ABLYNX application and then to decide whether an opposition should be filed. It is believed this constitutes good cause for the request.
