
REQUEST FOR EXTENSION OF



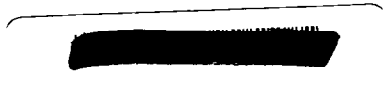
