This is the second request for an extension of time. This extension is necessary to enable counsel to confer with potential Opposer to determine whether an opposition might be required.


The subject Extension of Time is not entered into for purposes of delay, and it is therefore respectfully requested that the Board grant the requested Extension of Time.


