The trademark examining attorney has reviewed the request for reconsideration and is not persuaded by applicant's arguments. No new issue has been raised and no new compelling evidence has been presented with regard to the outstanding issue(s) in the final Office action.

The additional registrations submitted by the applicant do not obviate the refusal for several reasons. The registrations are for completely different marks; the cited registrations do not share any of the same terms in the mark in the instant application or the cited registration. Furthermore, the overwhelming majority of registrations submitted by the applicant do not support the applicant's argument in that the registrations are all for different individual names, not a name and a surname which is the case in the instant application. In contrast, the attached third party registrations for jewelry goods show that registrants often use their last name as a mark in addition to their full name.

Nor is the applicant's consistency argument persuasive as the applicant's proffered registrations are for different marks. The applicant is, again, respectfully reminded that prior decisions and actions of other trademark examining attorneys in registering different marks have little evidentiary value and are not binding upon the Office. TMEP §1207.01(d)(vi). Each case is decided on its own facts, and each mark stands on its own merits. See *AMF Inc. v. Am. Leisure Prods., Inc.*, 474 F.2d 1403, 1406, 177 USPQ 268, 269 (C.C.P.A. 1973); *In re Int'l Taste, Inc.*, 53 USPQ2d 1604, 1606 (TTAB 2000); *In re Sunmarks, Inc.*, 32 USPQ2d 1470, 1472 (TTAB 1994).

Accordingly, applicant's request for reconsideration is **denied** and the §2(d) refusal and name requirement (no consent given) are continued. 37 C.F.R. §2.64(b); TMEP §§715.03, 715.04(a). The application file will be returned to the Trademark Trial and Appeal Board for resumption of the appeal. TMEP §715.04(a).


