Miller Brewing Company, a Wisconsin corporation with its principal place of business at 3939 West Highland Boulevard, Milwaukee, Wisconsin 53208, hereby requests that its time for filing a notice of opposition to the above-entitled trademark application be extended for a period of 90 days, to July 16, 2003, for the reasons set forth below.

Miller Brewing Company believes that it may have reasons and grounds for opposing said application. In order to determine whether an opposition should be instituted, however, it will be necessary to obtain and evaluate the file history and market and other information. The time now set for filing an opposition expires on April 17, 2003, and it will not be possible to accomplish the foregoing by that time, nor is it believed that it will be possible within thirty (30) days from the present expiration date.

It should be noted that this request covers a period longer than thirty (30) days, and it is believed that good cause for the request has been shown. Should such showing not be considered acceptable, however, it is respectfully requested that this

request be treated as a request for an automatic thirty (30) day extension, as provided for in Section 13 of the Trademark Act of 1946, as amended, and Rule 2.102 of the Trademark Rules of Practice, with reservation of the right to request further extensions for good cause.
