REQUEST FOR FURTHER EXTENSION OF TIME FOR FILING OPPOSITION


The potential Opposers need the additional time to obtain the file history and then decide whether an opposition should be filed. It is believed this constitutes good cause for the request.

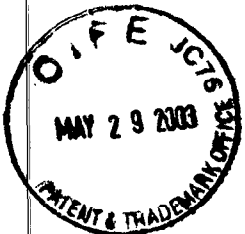

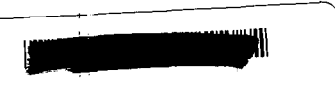
